## Registrar: Sarah Cook

- Registration with Crossbar has been great. There are 1,226 registrations as of today. JrGold will stay open until later in November.
- Locker Room monitors working with Kristen Hicok and Tia Senenfelder. The Volunteer Report has been getting updated daily, which is helpful. This has helped with the number of emails coming through.
- Flex Board Roster: This was approved at one point this fall and SCook checked in with Machele Whitmore at D3 and received no feedback. She was contacted in July. Suddenly things were not getting approved, and found out that Machel wanted 21 more people rostered as of October 4th. This is an issue because these people have to complete the background checks, register with USA Hockey, and complete SafeSport Training. Working on this list now. 56 identified as needing to be on the roster. As of now, 38 are on there. It appears that D3 wants everyone on the Org Chart and people that do not interact with players or have any kind of influence. Last year we had 32 people on our roster for reference.

continue to work on this. Motion to approve 50,000 donation to City of Plymouth for the
specific purpose to plan the facilitation of a fourth rink at PIC. MUgurlu made a motion to
approve the donation; LEmery seconded. Motion approved.
