7. Division Directors:
- a. Tykes – Nothing to report, things going well
 - b. Mites – Tourney went well, was successful. Nice Job by K. Russell organizing.
 - c. Squirts – No updates, things are going well
 - d. PeeWee – Roster size issues for the house team seems to have been resolved, things are going well. Looking ahead to next season, there is potential for 1, possibly 2 house teams (using the Select/House) Model. This will depend on returning player numbers, as well as coaching availability.

 - f. 16U/18U – Nothing to report
 - g. Girls - Successful season so far. Looking to next season, the plan is to again collaborate with Skan to field a girls team. Numbers could be an issue at the 14U level, as well as coaching unknowns. Exploring possibilities for TB team vs. Independent teams, will depend on numbers of skaters.
 - h. Travel – No updates
 - i. Snowbelt – S. Mercurio provided an update related to an upcoming snowbelt meeting. JAMs will be scheduled at this meeting. Coaches will have input, to help ensure teams are placed appropriately. The last day for Snowbelt Games is 2/8.
8. Hall of Fame Game for Syracuse Crunch: Former CYHA Coach and Retired Crunch Captain Gabe Dumont will be inducted into the Syracuse Crunch Hall of Fame prior to that evenings Game. There are several Teams playing in snowbelt games, but we will be encouraging CYHA families to attend to support Coach Dumont.
