- a. Steve Snowbelt Update S. Mercurio provided an update from most recent snowbelt meeting
 - i. Dual rostering that needed to be done is complete
 - ii. Pre-season starts next week, scheduling will be out soon
 - iii. Times for penalties are now consistent w/ NYS hockey recommendations
 - iv. Snowbelt numbers overall are down, likely due in part to rise of independent teams
 - v. Dual rostering motion passed
 - vi. There will only be one phase of pre-season this year, two had been the norm in previous seasons
 - vii. CYHA owes snowbelt \$75 for the organization and \$75 each per team we have
 - viii. A "Grow the Game" trailer is available to organizations
 - ix. The issue of parent fines has been tabled for the time being
 - x. GameSheets scorekeeping is still optional for snowbelt teams, CYHA will continue to use paper scoresheets.
- b. Rachel Snack Bar / Parent Org./Workers/Confirmation R. Abert provided an update on various topics
 - Working on getting a survey out to association members to determine preferred options for picture night. Winning survey option will be what we go with

- c. Division Director updates Each division director in attendance provided an update on their respective division.
 - i. Tykes: Going well. Games are getting scheduled. Will be doing 2 crunch nights. Jerseys have been ordered. Need to get official rosters together with 16-20 skaters per roster.
 - ii. Mites: 8U full ice proposal has been approved by NYS hockey. Looking to split 2016's, approximately 20 players. Tournament rules are out, same as last year. We are looking at pricing, particularly increasing entry fees to stay in line with what other organizations are charging. Tykes will be included in this years mite tourney, at a fee of \$100/team.
 - iii. Girls: Will forward 6U roster to T. Choe to add to register. Jerseys are being ordered/are on the way. Working to finalize 8U and 10U rosters. Currently no locker room monitors, lots of coaches.
 - iv. Squirts: Nothing to report
 - v. PeeWee: Nothing to report
 - vi. Bantam: Season is underway, first game was yesterday (10/19). Teams look good.
 - vii. 18U: Nothing to report
 - -K. Hayden added that a 16U player and 2 coaches were suspended.
 - viii. House: no major on ice penalties so far
 - ix. Travel: All good, season going well. 18U travel has one game left.

 - ii. C. Sandford is working on a way to include sponsor recognition in
