- ACCESS TO A VIDEO (HUDL OR SIMILAR) BREAKDOWN SYSTEM.
- TEAM WILL PLAY 50-55 GAMES, COMPETE IN SEVEN EVENTS (TOURNAMENTS AND/OR SHOWCASES, THIS NUMBER INCLUDES STATE PLAYOFFS).
- TEAM WILL HAVE 73 HOURS OF ON-ICE PRACTICE TIME (TOTAL INCLUDES POWER SKATING SESSIONS & SKILLS SESSIONS).
- TEAM WILL HAVE AT LEAST FIVE POWER SKATING FOCUSED ON-ICE SESSIONS WITH OUR CLUB POWER SKATING INSTRUCTOR, AMY CLAGGETT.
- TEAM WILL HAVE AT LEAST FIVE ON-ICE SKILL SESSIONS WITH OUR CLUB SKILLS COACH &/OR OTHER COACHES ON OUR USHL STAFF.
