Notes from September D3 Meeting

Squirt Coaches & Managers - EBUG for Squirts/U10 - We have made the decision to NOT allow an EBUG for Squirts for the 2022-2023 season. There will be exceptions (example-long term injury). This will be a pilot program and will be reviewed at the end of the season for determinations going forward. ***There will be 10 district squirt games. Begin scheduling games and scrimmage early to fill the 35 game limit. To ensure priority from referees, schedule back to back with another HYHA game.

Mites - D3 Rules & Regs not yet updated, but there are new rules. D3 is now allowing 3 games in addition to 1 jamboree. 3 games can be played against teams inside and outside of D3. Kevin Pote (Armstrong/Cooper) and I will be running the D3 Mite Committee. Feel free to reach out with questions.

HYHA HDC - September 18th will be the last day to make changes to team declarations. Ice schedulers will begin scheduling district games.

HYHA President - D3 director will host another presidents meeting in October. Let Matt know if there are questions/concerns that need to be addressed for upcoming season

Girls Coordinator - There are a few girls' hockey events coming up that we are encouraging D3 associations to participate in: IIHF Girls Hockey Weekend 10/8 -9, and Girls Try Hockey for Free (two events, 11/5 and 2/25). Both are great recruiting opportunities. We would like to see strong participation from D3 associations. No new movement on team declarations as we head into October.

North Metro - Has 5 teams for the 2022/23 season. Failed attempts to merge with OMG, ACYHA, and Coon Rapids. Currently looking at other options. I will keep you posted.
