Notes from February D3 Meeting -

We are in the process of gearing up for our year end tournaments and I am asking for all associations to remind players, families, coaches, etc to respect and honor the game.

There have been a number of suspensions to coaches, players and parents for violations of rules, fighting and abuse of officials during the past month.

Once we have made it through Districts, I am hoping to meet with each committee/directors to discuss the upcoming season and begin planning earlier than years past.

January 28-30 Minnesota Hockey Meetings:

This is a one-time USA Hockey registration increase for the 2023-2024 season.

**The fee increase that was approved is:**

- **6U participants at \$15 (currently \$0)**
- **7/8 participants at \$50 (currently \$46)**
- **9-12 participants at \$61 (currently \$46)**
- **13-18 participants at \$70 (currently \$46)**
- **Ø Adults no change from current: \$46.00**

Officials: Still in need of officials. USA Hockey states what we all already know, officials are down from previous years. As always, be kind to our officials as we are looking at ways to recruit officials.

There was a lot of conversation regarding whether or not tournaments should be allowed to be played during school hours. MN Hockey is looking at whether or not tournaments will need to be smaller in size with fewer teams. It was also stated that associations have the right to refuse games that are played during the school days. The tournaments and rules committee will work on this.

A survey amongst HS girls coaches will take place to determine the viability of the 15Us. Talk about combining age groups within girls, however this will take a number of years if it even occurs.

Game Sheet is going well. Very well received. Looking at ways to better leverage the options that we have within Game Sheet.

Fall CEP clinics – An all female CEP clinic was a success. Needs to be posted on the CEP Website.

For New HYHA Ice Scheduler - Several coaches/teams have reached out about lack of ice time for practices and scrimmages in January and February. HYHA needs to populate the ice schedule for the ENTIRE SEASON as early as possible. If needed, HYHA should purchase more January/February ice for the 2022-2023 season. More than 300 games have been rescheduled this season. Additional ice will give coaches flexibility to reschedule.

HYHA \$10,000 Fine - A few years ago HYHA was assessed a fine for a squirt team not participating in the year end district tournament. D3 didn't have a treasurer for several years. As a result HYHA was not billed for the fine. D3 books are now up to date. I had a conversation with new D3 director Paul Steenerson. He would like HYHA to keep the \$10,000 in the association for development. HYHA board will need to submit a proposal for how \$\$\$ is spent.
