D3 Updates: Bob Larson HYHA D3 Representative

Notes from March D3 Meeting

Coaches & Managers - Too many calls and email from coaches and managers for information already communicated and available. Next season we will hold associations much more accountable with the information within the Mgr. Meetings and Coaches Meetings. More to come when we meet with the Presidents for a debrief of the season.

Ice Scheulder, Coaches & Tournament Director - D3 President & referees met with Avario to discuss improvements that need to be made with scheduling. 2 major problems: the number of rescheduled games and the number of single games scheduled. Rescheduled games cause some of the single games or cause other games to be rescheduled so that it is not a single game. Another thing that causes many reschedules is tournaments. Starting this year associations will be required to have the tournaments for all their teams confirmed and entered into Avario before scheduling for that level. The game rescheduling procedure will also have some changes made to it. There is a meeting scheduled for the schedulers on March 22.

Coaches & Everyone - Total incident reports were down from last season (91 in 2022-2023 vs 121 in 2021-2022), but match penalties and coach ejections were up by a few this season. Biggest issue I had during the season was getting head coaches to report game misconducts and match penalties within District 3 rules. All game misconducts and match penalties need to be reported to the supervisor of officials within 48 hours of incident. I was forced many times this season to reach out to coaches directly to get the suspension information the district requires. ***Proposed change from officials - Change reporting time from 48 hours from time of incident to 24 hours. Everyone has immediate access to the GameSheet and everyone has immediate access to email. The old process allows 48 hours, in that time a team may play multiple games, especially during tournaments. It is the responsibility of the supervisor of officials to get the time, date, and location a player(s) or coach(es) will be serving their suspension(s) and to make sure no one is playing with an ineligible player, which would cause game forfeiture. Reporting is not a time to appeal suspensions, game misconducts and match penalties as not subject to appeal. Failure to report is a one game suspension to the head coach. Propose a way for head coaches to report game misconducts and match penalties on the D3 website. Looking for suggestions. Is it possible to have a drop-down fillable form that is available to coaches would maybe simplify the process.

Girls Info - District and Regional tournaments completed for 15U and 12U. Proud to have the six D3 teams competing for state titles: OMGHA 15A, Wayzata Blue 15A, OMGHA White 15B, OMGHA Black 15B, Wayzata Blue 12B1, and Armstrong Cooper 12B1. Congratulations to Minneapolis 12B2 for winning the District 3 championship. 10B1 and 10B2 district tournaments are under way in St. Louis Park and will wrap up this coming weekend. The D3 Girls Coordinators will meet in later April to debrief on the season and begin preparation for next season. Primary topics for this meeting: Review team declarations against results, 15U opportunities, etc.

HP/Tier 1 - Boys have added Brandon Anderson-Delano Bantam A to the HP 14 coaching team. Garrit Otten-Orono PWA, is joining the 15s. Garrit coached Tier 2 Prospects last season. It is really great to have new coaches getting involved representing a good mix of D3. Nominations for HP went out the first week of Feb for the 15s and about a week later for the 14s. This occurs after coaches submit nominations and have the opportunity to review and confirm athletes that should receive the invite. All PW A/AA and BA AA/A coaches have been asked to assist with evaluations at HP tryouts.

Unfortunately, there are always coaches that do not respond or participate in evaluations. Offered pre-triout skates for registered athletes (boys and girls) and those three sessions are full. Those are optional opportunities at minimal cost for athletes to stay fresh and ready before tryouts. Tier 1 and 2 tryout dates should be published soon. Waiting for final confirmation on goalie only session. Dates will immediately

follow the HP Camps. Mackenzie/Lindsay-Girls - nominations have gone out. Reaching out to coaches to evaluate at tryouts.

13u Futures Program - we have 36 boys' skaters + 3 goalies (only room for one more goalie) and on the girls program we have 26 skaters + 2 goalies (room for an additional 10 skaters + 2 goalies). We have offered D5 spots to the boys skaters on our waitlist. Schedules are posted on the D3 website under HP/13 Futures for both programs. we have a coach locked in for the boys' program - Christian Jolicoeur (Mpls PWA) but are still in need of a head coach and assistants for our girls' progra
