A summary of this meeting includes the following items:

1. Call to Order: 6:10
2. Attendance – see above
3. President Remarks
4. Warriors
 - a. 15A registration numbers are lower than expected. 17-18 girls registered right now. Co-Op vote was to go for 1 team, but we've been encouraged to keep the second team until after HS tryouts as there will be players looking for a place to play (similar to JG teams coming together after HS boys tryouts), so we are waiting to cancel tournaments, etc.
 - b. Options include talking to other associations (in discussions with Chaska, EP, and expect ~5 players to need a home) or joining a SW team with multiple schools.
 - c. Discussion regarding the fact that there are no Mound players registered for this team – should this remain a Warriors team or should it become an Orono team?
 - d. If we have a single 15B team, no evaluations would be required. Could have some pre-season ice time, and the team could start right away.
5. Evaluation Document
 - a. **BB Vote:** Motion to Vote to approve the travel eval plan – Sean: Motion to vote to approve travel eval plan (with light formatting) Chris, 2nd, All in favor. Approved unanimously
 - b. Britta will work on reformatting

 - b. Extra ice is still needed – reaching out to other rinks
