#### **VP of Hockey Operations (Mark Karkoska):**

- Pure Hockey has provided several small and medium practice jerseys that were dropped off at the Jaguar office because of some of our problems with wrinkled patches. At the end of the season, Pure Hockey will provide the club with a sponsorship check as part of the agreement, which is expected at the end of February. Also, I am working on a document for the website on online ordering instructions for new players to the club to make the process easier as we continue the relationship. Pure Hockey has committed to making sure we are happy with the relationship.
- Second, Squad Locker is a year-round online store we can utilize through SportsEngine. Shopping with Squad Locker provides money back to the club. We've had access to the site in the past, but we've had very few purchases through the store and saw very little money come back to the club. With the new logo, this might be a good time to revisit this online store. John and I have submitted some new images to the site, and I am working on putting them back on the website. This might be a good secondary source of apparel and doesn't cost any money to stand up.
- Finally, I've restarted conversations with Sprocket Sports as a possible replacement for SportsEngine. Cav will be sending a new proposal on the cost. The nice thing about Sprocket Sports is that it replaces SportsEngine, includes a new website and payment options, and would replace the monthly cost of MailChimp. The next step would be having a demo where they could walk us through the website.
