Actions:

Judy Fracker from The Foundry welcomed the CSHL group and explained the mission and work of The Foundry.

Review and approval of minutes from the CSHL GLM (via Zoom) February 2024. Motion to approve minutes offered by Parma (Kraguljac) seconded by Garfield Hts. (DiRosa). Minutes approved.

CSHL treasurer Christopher Kendel presented the annual financial report. A brief discussion followed. Financial report approved.

Elections for the 2024-25 CSHL Board of Directors for terms expiring in 2026. Four candidates (Komma, Seigley, Stojak and Wahl) provided statements. With four positions available, the candidates were elected by acclamation.

CSHL Rules Committee chair Mike Radosevic presented the proposed changes to CSHL Standing Rules. Radosevic presented a group of "Clerical/Housekeeping Rule Change Proposals" that were passed unanimously as a group. Radosevic then presented several Substantive Rule Change Proposals that were discussed and/or amended. Each substantive rule change proposed was voted on individually.

CSHL Secretary Jim Smith presented the proposed CSHL calendar for 2025-26. The calendar was approved. Smith also provided a summary schedule of 2024-25 CSHL League meetings, scheduling events, monthly CSHL Board and HOP Zoom meetings, CSHL playoffs and NCHSHL meetings and playoffs.

New business: The CSHL website will be hosted by Crossbar for the 2024-25 season. Michael Goetz is leading the transition.

Old business: The CSHL will use the digital scoring system GameSheet beginning in the 2024-25 season. For the 2024-25 season, GameSheet per game fees will be absorbed by the league budget. In 2025-26 programs need to budget for that expense.

Best practices and training opportunities for GameSheet were discussed.

The CSHL community will host the 2025 USA Hockey Girls/Women 19U Tier II national tournament. John Stojak is the chair of the host committee. Dates of the tournament are April 2-6.
