[FYI _ MINUTES From what I recall from other orgs, generally speaking minutes are to capture votes officially. The easiest way to keep minutes is to build off agenda. Conversations that need to remain confidential can have a general "Discussion of Issue". Conversations that are updates can refer to the PowerPoint or Agenda like "Report/Updates per email/agenda". For voting, we need to capture who made the motion, who seconded and should include whether or not the motion passed. (You need to ask for: In favor, Against, Abstain? but you don't have to write down how each person voted) If you do an email/online vote, you need to capture all responses and save. The assumption is, in public meeting, there are other people noticing votes and can confirm the motion passed or did not pass if questioned. An online vote would require documentation in case it was questioned] Remove this prior to saving as official doc (save as Date_Approved Minutes).

- Brief History of Team Colorado – 2017 had 16u Tier 1, 19u tier; leadership at CAHA decided to start Tier 1 from other orgs, scattered at first. This season focused on one place for all teams. Next year at Drill House for off-ice.

First Period

- 2024-2025 Season Review and Financials: PowerPoint of season highlights for 14s, 16s, 19s. Some really great accomplishments this season. Under budget by about 12k. Talked about some comparisons and planning towards future. Next season's budget will be discussed. Nationals will be a final true-up for the 14U team. The season starts with tryouts, summer and all programs through the end of spring (end of May).

Ice Cut

- Survey Feedback/Results – Included in PowerPoint, and some details came out of Crossbar. Mixed messages coming out of the survey. A competitive season doesn't work without coaches and players really working hard and the team finding balance. Finding the best tournaments while already having a competitive schedule – mixed bag on survey. Next season looks to be some top tier competition. Scheduling is always a compromise to get to those competitions. Looking at travel every two - three weekends. Trying to miss the least amount of school possible.

Second Period

- 2025-2026 Season Forecast – Drill House will really help consolidate practice times, rather than shuttling around. There's added convenience and value and resources for a little more to pay. Ice blocks of time at FSC with an added session on Fridays at South Suburban to get in extra skill sessions. Coach Chris will lead the skill sessions along with Colin, goalie coach, as well as other Tier I coaches. Q from YouTube – dry land before or after practice or separate? It affects attendance when it isn't at same time. In college, its lift and then skate or skate then lift, 2-3 times a week. Get in those habits that will help at college. Adding mental performance training with Ryan Ford starting in August. Practices schedule and proposed Competitions schedule.

Ice Cut

- 2025-2026 Season Budget (to date) - Increases from Goalie coach, bookkeeper, drill house and mental performance coaching. Budget appropriately for other systems which we need like video, association insurance, Crossbar and QBs fees and extra coverage. Planning on travel fees being conservative. 14U travel fees will increase to \$600/month. 16u and 19u same travel fees at \$1600/month. **Q about whether or not Nationals is in budget for fees.**

Third Period

- Separation from CAHA – Addressing the separation and moving away from needing CAHA for everything. Should be simple separation since we have almost all the pieces ready.

Overtime

- TC Scholarship Program – You can see in the presentation where we can get budget for scholarships. Decisions on how much to set aside for scholarships and what the criteria would be and what sorts of questions we would need to ask. Deadline to apply is May 1st and reviewed before tryouts so families would know what the finances are.
