Board of Directors Meeting Minutes

Feb 17, 2026

1. RMD update with Nikki
 - a. Everything is moving smoothly
 - b. Volunteers - We (TC) need to fill all the spots for South Suburban. There needs to be at least one parent per TC family volunteer for something. We aren't volunteering to run the scoreboard; we're making sure people have badges. TC players can volunteer as well.
 - c. Estimated proceeds - estimating \$10k for TC and \$10K for Oak. Will get final budgets once the food is finalized.
 - d. SafeSport/Locker Room Monitors - There is a potential that the tourney gets audited, so we need to make sure that a Tier 1 rostered adult is monitoring locker rooms anytime the players are in the locker room. But don't need a monitor if two coaches are in the locker room.
 - i. There is a separate room to assess injuries with two SafeSport trainers, so no monitor is needed there.
 - e. No one can livestream the games, games are only available via USA Hockey streaming service.

2. Approve January Meeting Minutes

Roger motions to approve meeting minutes, AJ seconds, all approve. Motion passes.

3. Director of Hockey updates
 - a. Member Handbook
 - i. Chris to send follow-up email with new handbook and old handbook links
 - b. Rankings update (19s - 42nd, 16s - 31st, 14s - 33rd)
 - c. Spring Program Update
 - i. 68 total sign-ups: 10U has 20 players (3 goalies and 17 players), 12U has 48 players (4 goalies and 44 skaters).

 - a. 10U Prospects Futures

 - c. 12U Elite Futures
2. Roster sizes will be limited to 15/16 skaters and two goalies.
3. Discussion regarding discounting the price from \$595 to \$495 because we are now rotating three teams through two ice slots. **Decided to discount the price per discussion.**

 - a. Karen will need check-in help
 - ii. Main ID Camp - 27 registrations (5 goalies; 22 skaters). Will be capped at 36 skaters. Starts March 31.
 - iii. May Development Skates - after tryouts, 3 x week (9 sessions)
 1. Trying to see if Perfect Skating can do those for us so our coaches have a break. Give players something different, and hopefully it promotes Perfect Skating as well. Currently investigating cost with Jason Graham.

 - i. Coach Lockrem - Head Coach 14s, 16s
 - ii. Discussion regarding possible 19U head coaches and 14U, 16U, and 19U assistant coaches.
 - iii. Roger has been in contact with possible coaches
- e. TC General Meeting - targeting March 19th with a board meeting on March 16th to make sure we're prepped for the General Meeting
- f. Summer Programming Update
 - i. College/Pro Style Camp June 19th - 21st; finding it hard to nail down coaches. June seems to be a busy month for college coaches.
 - ii. Offensive/Defensive Camp - July 17th - 19th; possible flip with June dates if it's easier to secure coaches.
 - iii. Getting rid of Sunday Summer Skates; trying 3v3 Game Nights at the Stable or Elev802 during the week instead

 - i. Discussed competitive tournaments and timelines
 - ii. Discussed MN NIT rink locations and game times seemed unfair.
