USA Hockey Registrar – Krista White

- Practice Ice scheduled. League beginning to be scheduled.
- We had 6 travel teams last year and we will have 6 travel teams again.
- Uniforms: Will order do bulk order.
- Official practices starts Aug 24 at discretion of HC's.
- Aug 29th will be Welcome Back to Hockey.

Coaching Director – Eric Manning

- Will send coaches clearer communication on the trainings they need to complete to be able to be in the ice and on the bench.

Youth Hockey Coordinator – Maria Grose

- Learn to Play: Told current participants to hold onto their gear if they plan to play in summer learn to play and if they don't want to continue to the next step, they can turn it back in.

President – Ashley Courier

- Registration numbers were up from last year
- Looked into Zephy. Opened account. Krista is doing the same.
- Submitted Grant to CAHA - asked for money for off ice training, LTP and Goalie training
- Received contract from rink, forwarded to Board to review. Same contract as previous years. We have tried to get them to change one-sided terms with no luck. They don't change it.
- Completed CAHA Renewal online in early June
- In the process of changing over checking accounts. Name is changed over, but have to get access and credit card.
- Kristy to move to Treasurer. Will advertise for Secretary in next Spin.
- PO Box – Still can't find information. Will have to reach out to Cindy.
- I will reach out to the other VP candidates to see if they are still interested. They no longer have kids in the program.

Board Discussion

- Clarification on discounts. There are no combining discounts. There are a sibling, HC and military discounts - 10%. Multiple children: 1st pays full, subsequent discounts after apply.
- We need to buy pucks.
- Caitlin's team budget: reduced to \$1,950 from \$2050.
- David Gele's team budget: 13 players at \$1,750.
- POP pricing - to attend 1 full ice practice per week, no ½ ice. \$350 pricing for POP pricing all of which goes towards team budgets.
- \$1,200 for G.M. for all practices, friendlies and tournaments - no league. \$100 of the \$1,200 will go to the organization.
- D.G. will be informed that L.A. can be a parent volunteer (Clock, score sheet, music) on game day's only but cannot be manager or represent the organization in any way.
- It will be communicated to D.G that B.H. cannot be a coach.
- Elite Training: 16U-19U AA and AAA players only. Per Ashley was changed to all 14U to 18U players. Spoke to coach A.S. and he had no preference. Wants to help as many players as possible. We don't have enough high-level players to fill that clinic. We may not even have enough for an 18U team, and very few 16U players are AA or AAA – confirmed with Cyclone coaching staff.
