Treasurer Report: Budget Update: Cindy W: Bank is at \$59,509. We just got the February Ice Bill. It was \$20,148.00. Insurance policies were paid and renewed for the year.

A new Cyclones Reimbursement Form is now in effect for reimbursement items across the Cyclones League. Discussion of office supplies and dates for reimbursement were discussed.

All reimbursement items must to be submitted 30 days after the receipt of invoice. A team manager meeting will be held at the start of the season to make certain that this is clear to each team at the start of the season.

President Report:

Coaching:

Dave N. has declined to take on the 16U coaching position. David Zannella has agreed to serve in that role.

14U tryouts will be held at the same time as the other teams this season. We still need a coach for this team. We will be advertising again for the coaching role for this team.

House Matrix Budget for next season will be discussed and voted on in April.

CAHA is working on hosting an end of season tournament for House players. It is in the beginning stages of development for it to be live for the upcoming season.

CCYHA State Tournament was a huge success. Brad H. congratulated the Cyclones on a job well done.

18U Team is headed to Nationals on April 2nd-6th. The team is practicing at this time and is preparing to attend Nationals in Utica NY.

Learn to Play, Cub, Grizzly and Bear has a solid number of players signed up for these groups beginning on March 31st. We are looking to make a small profit at this point.

Pull the Fire Truck was cancelled this year due to lack of available participation. We will set things up earlier next year in order to participate next year.

Vice President Report:

Suggestions for improving the position for next season include the need to come up with a more advanced system for tracking players after each game. The VP needs to have knowledge of any Match Penalties or Game Misconducts immediately following the game.

Registrar and Coaching Director will work closely next season regarding House and coaches. Registrar will issue the link directly to the Treasurer in Cross Bar to track the players in the system. House players need to be tracked closer. This season we struggled

with the transition of the new system from Game Beast to Crossbar. This season we will start with just Crossbar.

Youth Coordinator:

Discussion of new engagement from persons attending Try Hockey for Free. We have a large number coming out of Try Hockey for Free. Maria wants to set up another THFF in July. We need more helmets in order to hold more skaters.

Equipment donations are being accepted on a limited basis at this time. We are in need of helmets.

THFF was held last weekend. We had 60 skaters at the event.

16 skaters have signed up for Learn to Skate and several more for LTS.

Coaching Director:

We need to have another system of communication for the coaches to discuss openly with other coaches during the season. We have the GroupMe in place, but it may be helpful to have another form of communication issued for the group to communicate freely.

Travel Budgets:

Discussion for Travel Budgets took place at this meeting. The budget matrix was reviewed for each team.
