Donation Request- Dutchroom Request \$250 for swim team Motion made by Mitch kellin to approve the donation, seconded by Andy Haarklau. Motion carried by board vote.

Donation Request- The Grand Rapids Sports Hall of Fame is requesting a donation for \$300,

inductees this year include a hockey Team and individual hockey players motion made to approve donation by Jon Toivonen Seconded by Andy Haarklau. Motion carried by board vote. Discussion- Gambling sites requesting more raffles, and more things that can be done at the sites. "Tip boards" also known as meat raffles some sites are currently doing these. Would possibly need to staff these things with a GRAHA employee. Hayslips expressed interest in hosting BINGO as well as Redeye, Blackberry. Things to consider with bingo would need to have at least one paid employee to be there. Redeye has a plan to run their Bingo with other volunteers. The expense for bingo also can be expensive; the cost for getting the Hoot and Holler up and running was about \$10,000. Kendra stopped at Fish Tales and they would like to switch to GRAHA but they really want to do BINGO and would be a deal breaker for them.

Concession update- Cara Scott, Troy Scott- Needing 2 more chest freezers, one little one for upstairs and one big for downstairs. Motion made by Andy Haarklau for Troy and Cara to spend up to \$1000 on freezers, motion seconded by Ryan Dekich. Motion carried by board vote Vending- Candy machine is not working, looking to get the machines picked up that are not currently working. Anna is going to help with this.

Cara would like to do some simple training videos for concession stands. All in agreement that would be a good idea and a helpful tool.

What additional items can we bring in to add substance to the menu, possibly pulled pork still looking at possibly doing subs, trying to reach out to Mad Dog's to inquire about this.

Secretary's Report- Shawnna Rude, motion made to approve the October secretary's report motion made by Andy Haarklau seconded by Dan Mertes.

Discussion on DIBS coordinator contract will get duties for position and revisit in December also getting full duties for gambling positions as well.

Financial Report- Anna, Discussion- Bantam B1 proposed budget \$12,000 that would be used for an extra tournament given the fact that they are having more players on that team. Typical budget is \$6000 per team board thinks that they will need a higher budget but feels more comfortable with giving an extra \$4000 for a total of \$10,000 given the extra tournaments that will be needed motion made by Andy Haarklau to approve the additional \$4000 seconded by Ryan Dekich. Motion carries by board vote.

Coaches stipends non parents \$3000 for head coaches peewee/12u and above assistant coaches \$1500 capped at 2 assistant coaches Motion made by Mitch Kellin Seconded by Dan Mertes. Motion carried by board vote. Motion made to amend this amount to \$3500 for non parent head coaches and \$1500 for assistant non parent coaches capped at 2 per team also to include squirts and above motion made by Anna Peters seconded by Shawnna Rude. Motion carried by board vote.

Motion made to approve October Financials by Ryan Dekich seconded by Mitch Kellin

Sponsorship update- Ryan Dekich All sponsors have been invoiced as of 11/1- will resend if not paid by 12/1.

Potential sponsors for pavilion warming house to make locker rooms- Mesabi Metallics and possibly Park State Bank. Ryan will be following up with them as the board agrees that this is very important.

Discussion all members present want to make sure that there is open ice for community members to enjoy on the pavilion once complete

Molly- Universal sports auctions contacted Molly about putting items at the arena, they bring everything, carry liability, and they take responsibility for everything. GRAHA would receive 20% of profit from auctions. Molly has a call into Woodbury to see how this has worked for them. All members present agree that it sounds good and we should give it a chance.

New Locker Room policy- tournament director will collect one set of manager/coaches car keys and then give them the locker room keys and then after the game is completed the tournament director will need to "check out" the team to make sure the locker room is not a mess before giving keys back.

Ryan Making sure that school rinks are going to get flooded so we can get ice in a timely manner for outdoor practices.

Discussion: Possible cutting ties with Live barn as it is glitchy GRAHA does not control the actual livebarn being in the facility but we could offer someone else to come and install a different system possibly working with MNhockey.tv????
