Safesport



What is Safesport?


• USA Hockey's SafeSport program provides resources to ensure the safety of all involved in the game both on and off the ice.

Who is Required to Complete Safesport Training?

- ALL Coaches/Asst. Coaches
- ALL Team Managers
- ALL Volunteers that will interact with the players (locker room attendants, dryland trainers, etc.)
- ALL Board Members
- Must register with USA Hockey as a volunteer and complete safesport training and background check
- Must be done EVERY year.

Safesport Policies:

- NO CELL PHONES or Camera enabled devices are allowed in the locker rooms
- Locker Room Attendants required
- Travel Policies




D10 Locker Room Phone/Camera Penalties




Any player or parent that is caught using a cell phone or camera in the locker room is subject to the following disciplinary action.

	Player	Coach/LRM/Adult
1 st offense	2 game or 2 week suspension (whichever is longer)	2 game or 2 week suspension (whichever is longer) \$500 fine to the individual
2 nd offense	4 game or 3 week suspension (whichever is longer)	4 game or 3 week suspension (whichever is longer) \$750 fine to the individual
3 rd offense	60 day suspension	60 day suspension \$1000 fine to the individual \$1000 fine to the home association



WHAT DO YOU NEED TO DO TO BECOME A COACH?

- In order to coach, you must complete all steps listed below. Deadlines are listed for each and are not negotiable. We are governed by District 10, MN Hockey and USA Hockey and they dictate when each of these needs to be completed. You MUST ensure that you have everything completed on time or you will not be allowed to coach.
- YOU WILL NOT BE REIMBURSED FOR ANY FEES IF YOU DO NOT DO ALL STEPS.
- 1. USA Hockey Member Registration https://membership.usahockey.com/
- 2. RYHA Registration & AAHA [Anoka]
- 3. Complete USA Hockey Required Training
 - 1. SafeSport Training
 - 2. Screening and Background Check (every 2 years) Status available USA hockey
 - 3. Age Specific Modules
 - 4. Concussion form signed (every year) & concussion training (every 2 years)-UPLOAD
 - 5. Current CEP Certification
- 4. Attend Mandatory D10 Coaches Meeting (Traveling Only)



Billing Process

Billing process will be managed by your own association

- Anoka and Rogers will divide bill proportionately between associations.
- Anoka Teams have moved to a flat rate bill at the time of registration.
- Rogers Teams will no longer receive a bill from Anoka. Everything will be billed through Rogers.
- Every Team will have a slush fund to pay for scrimmages, extra tournaments, team events, ect. (Amount & Process TBD)




Ice Scheduling



- All ice is scheduled through Anoka ice scheduler who will be given ice hours from the Rogers ice scheduler to incorporate into the total ice time bank
- Given there are 2 sheets of ice at Anoka and 1 sheet of ice at Rogers and 1 sheet at Super Rink the ice time is not split 50/50, but we are working to get as much ice at each location as possible. Rogers has purchased a significant amount of ice at the Super Rink and some events will be held there.




Player Development



- The BASE will be providing Skills nights this year on Monday nights. It will be station based as well as providing cross ice 3 v 3 and 4 v 4.
- ATTITUDE Goaltending will be our vendor for goalie training this year. More details to come.
- Girls will have individual dryland available through ETS (Rogers or Coon Rapids) this year instead of Acceleration.
 - Coaches are encouraged to use the Anoka dryland facility for team oriented off ice work and also to use the the upstairs at either Anoka or Rogers for film and whiteboard study

Tryout Process - Scrimmage



- Using a random schedule, skaters will be divided into groups for each scrimmage session.
- These groups will be posted online prior to tryouts.
- Skaters will participate in two sessions on Sunday then split into upper and lower groups going forward.
- Groups will be reshuffled in between the Sunday sessions, so pay attention to the website so your skater arrives for the proper session
- The lines and positions are to be changed by random on the bench so each skater is skating with and against new skaters as often as possible.
- Each player will be evaluated the duration of the scrimmage.
- Each judge will evaluate every player.
- New this year*** We will be posting numbers, not names, for the upper and and lower splits.


Injury Policy

INJURY RELATED TRYOUT POLICY


Policy Manual: Section V, Sub-section D

5. Any player unable to participate in tryouts due to injury, illness, or other Board approved absence will be evaluated on prior year performance, previous coaching recommendations, and current coach recommendation to determine the most likely team placement. If deemed necessary, the player will then be evaluated to ensure proper placement.




Tracking the puck




Team Selection



The order of events will be as follows:

- The A level coach may be provided access to the rank groupings, for each player at that level who has demonstrated the ability, based upon tryout score, to make that coach's team.
- Top 70% skaters for U10, top 60% skaters at U12 and top 50% skaters at U15 are locked in for the A team, remaining team is based on coach selection
- The A level coach can solicit feedback from those in attendance in order to complete and submit a proposed roster of the team under consideration.
- The proposed head coach will then be asked to list his roster for the group to review.
- Any changes from the final order derived by the tryout process offered by the evaluators will need to be discussed and defended by the coach to the group.
- The group will be responsible for thoroughly discussing those changes amongst themselves and to make sure the manual is being followed. Final decisions on rosters will be made by a group consisting of some or all of the following: President, Vice-President, Development Director, Tryout Director, Head Coach and Girls Directors. There will be equal representation from both associations.
- The B1 teams will be divided equally by RYHA and AAHA board members in attendance after the A team has been selected.
