- I. Meeting called to order at 4:02pm
- II. **Roll Call:** Bagley, Bemidji, Crookston, East Grand Forks, Hallock, Red Lake Falls, Roseau, Thief River Falls, Warroad, Lake of the Woods, and Walker
- III. **Associations Absent:** NA
- IV. **Agenda Additions:** Squirt District discussion – Huewe. Bemidji moved; Roseau seconded.
- V. **Approve Winter Minutes:** Bemidji moved/Walker-Second. Motion approved.
- VI. **Spring MN Hockey Recap:** Dragich and Elliott recapped the April 26-28 meetings. The Girls 12/13U Pilot Program will remain intact as run the past two seasons. The MN Hockey VPs said they would be very accommodating in waivers with the 1/3 rule and the A/B playing level for 13-year-old players. A solid effort was presented to make a permanent change, but the majority was not in favor. Locker Room monitors continue to be an issue everywhere in the country. The 2025-2026 season will be a rule-change season, so talk has begun for bringing back tag-up offsides along with other changes. Neck guards were discussed and beginning August 1<sup>st</sup> all players and referees 18 and younger must wear neck guards in some form. Mark Elliott was awarded the President's Award at the yearly banquet.

Also discussed moving up the date of our Spring meeting to try to determine playing levels prior to tournament registration beginning.

  6. Referees-Ron Laturi-not present. 18 and younger need neck protection for 2024-2025 season. Solberg reported he and Tyler Hagl are doing Referee Clinics for level.

Teams are not pre-determined but maybe the player didn't have a great tryout. Looking at a few changes for next year. Can have up to three coaches per level so can use help at all but 15 Boys.
8. Awards- EGF will provide awards for 2025 district tournaments.
9. Tournaments - Mark D. reported no changes for 1024-1025 season. Will send out information when completed by MN Hockey.
10. Risk Management-Continue to report injuries if you have them. USA Hockey is working with a new insurance company. No longer K&K. Accident reports will now be completed online.

**Old Business:**

2. Locker Room Monitors – Major focus for 2024-2025 season through MN Hockey. Issues and lawsuits continue to happen across the country because of locker room issues.
3. Waivers – must have for players moving, changing schools, 13U playdowns, etc.
4. Girls 12U/13U Pilot Program – MN Hockey will keep the program setup as is. The VPs of the Maroon & Gold Regions said at the state meeting that they would be accommodating with waivers if associations can provide information on playdowns being the best for player development, maturity and remaining playing hockey. TRF did not like how district teams manipulated rules last season.

**New Business:**

1. CEP Certifications – the date for coaches completing certifications is being changed to December 15<sup>th</sup>. Registration is now open for the 2024-2025 season and clinics are supposed to begin earlier.
2. District Director Election – Mark Elliott was nominated by Bemidji and seconded by Roseau. No further nominations. Elliott will serve another three-year term to expire in 2027.
3. Squirt District Tournaments – discussion was had on moving the squirt and 10U tournaments up a week or two in February to avoid conflict with the regional tournaments. Most receptive to the idea and will discuss for future years. The dates will remain the same for 2025 as some associations have teams playing in tournaments those weeks in February.
4. The Fall meeting will be held in Roseau at Gene's – 1095 3<sup>rd</sup> St NW - 4pm on Monday, September 9<sup>th</sup>, 2024.
