Terms and Conditions

This agreement, issued by Delta Skating Association, PO Box 395, Delta Junction, AK 99737, hereinafter referred to as "DSA" and issued to customer, hereinafter referred to as "Lessee" and is valid for all time rented.

Fees & Payment

All groups/organizations/individuals renting time shall be charged the applicable rate approved by the DSA Board of Commissioners. An hour sheet of ice rental is \$150 and includes an hour of community room use.

Checks and cash are accepted for payment, checks preferred. \$30 NSF Fee. Checks payable to Delta Greely Youth Hockey. Cards are accepted for an additional \$10 fee.

Indemnification

Lessee shall defend, indemnify and hold harmless the DSA (organization, members, volunteers, and Board, against all actions, claims, demands, liabilities, injuries and damages, whether to persons or property or both, which may be imposed upon or incurred by the DSA because of, or arising out of, any act, default or omission on the part of the Lessee in connections with the activity which the Lessee is conducting. The same indemnification shall apply for the City of Delta Junction.

Damage or Destruction of Premises

In the event the premises are destroyed or becomes damaged to the extent that they are not fit for the use, time reserved will be terminated. In the event of such termination, the DSA shall refund to the Lessee all sums, heretofore, paid by the Lessee for the time that has been terminated. It is expressly understood between the parties that the DSA shall only be liable for refunding fees paid, and shall have no liability to the Lessee for any other costs, expenses, lost profits or any other claims which the Lessee may have incurred or anticipated.

Repair To Premises

The Lessee accepts responsibility for repair of any and all damage to the premises resulting from acts associated with their usage or event. The Lessee shall have the option of performing any repairs to the specifications of the DSA or pay DSA the actual cost of the repairs. Settlement of all repair obligations shall be accomplished within one week of the duration of event.

Conduct

Persons under the influence of intoxicating liquor or narcotic drugs shall not enter, be or remain in or on facility premises, nor shall any person bring within, possess, give away, sell or transfer any intoxicating liquors or narcotic drugs in any indoor or outdoor DSA facilities.
