# **Board Member Reports/Updates**

# A. President Update - Adam

- a. Bantams
  - Adam contacted all 4 organizations to inform them we won't have a Bantam team this season and provided player names
- b. Open Board Positions
  - Rink Manager still no applicants
- c. Lease Update
  - Adam and Tanya will be attending the public property committee meeting on Thursday the 13<sup>th</sup>; will be asking for a 5-year lease
- d. Fair Stand Purchase
  - Owner is offering to sell the fair stand to the hockey league; \$25,000 over 10 years, 0% interest; \$2500 to be paid every year after the fair
  - Kevin made motion to purchase the fair stand; Adam 2<sup>nd</sup>; all in favor; motion passed
  - Need to draft a contract to purchase; will share at the next meeting
