"No Pay, No Play" Policy 2025-2026 Season

The following provisions apply to participation in hockey programming with Littleton Hockey Association ("LHA").

In order to ensure the continued financial health of LHA and its ability to maintain hockey operations for all LHA families, it is paramount that all player financial obligations be met in a timely manner. LHA understands that hockey represents a large financial commitment, and that unexpected personal circumstances do sometimes arise that make it difficult to meet this obligation. LHA also understands that team fee assessments represent an additional financial commitment for families over and above the cost of registration fees. The LHA Board of Directors (the "Board") provides financial flexibility to members with various payment options and assessment schedules, but will strictly adhere to the policies set forth below.

- 1. Players with outstanding LHA registration fees and/or outstanding LHA team fee assessments from any prior season will not be allowed to tryout or play in any subsequent season or program until the outstanding LHA registration fees and/or outstanding LHA team fee assessments are paid in full. There will be no exceptions to this rule.
- 2. Players with outstanding LHA registration fees and/or outstanding LHA team fee assessments from any prior season may be reported to the CAHA Delinquent Player List ("DPL"). Players reported to the CAHA DPL may not participate in any activities for any team or Member Association governed by CAHA under the financial obligation is satisfied. Any LHA player listed on the CAHA DPL desiring to move to another CAHA Member Association must first obtain a full Financial Release from LHA.
- 3. All LHA registration fee payments are due in the amounts and at the times set forth in the 2025-2026 Fall Registration Fee schedule listed on the Littleton Hawks and/or the Colorado 14ers website. All LHA team fee assessments are due within seven (7) days from the date of assessment.
- 4. Issues with registration fee payments should be brought to the notice of the LHA Administrative Director prior to the payment due date. Issues with team fee assessment payments should be brought to the notice of the team treasurer prior to the assessment due date. Payment issues brought to the attention of the LHA Administrative Director and/or team treasurer will not trigger an automatic player suspension for non-payment, so long as satisfactory financial arrangements have been made with and approved by the LHA Administrative Director and/or team treasurer.

- 5. If a player's registration fee payment or team fee assessment payment is delinquent, and if other financial arrangements have not been approved by the LHA Administrative Director and/or team treasurer, the "No Pay, No Play" policy will immediately take effect. The player's family will be notified in writing by the LHA Board Treasurer. The player's family will be provided an opportunity to present payment or provide a good faith effort toward reconciling past due fees. Payment compliance must be made at that time, or other satisfactory financial arrangements must be made at that time in the sole discretion of the LHA Board Treasurer. If payment compliance or satisfactory financial arrangements are not made, the player's coach will be notified and the player will be immediately suspended from all LHA activities by the Board. In the event the player's family does not respond to written notification by the LHA Board Treasurer under the provisions of this Section 5 within two (2) days, the player's coach will be notified and the player will be immediately suspended from all LHA activities by the Board.
- 6. Players suspended for non-payment under the provision of Section 4 will not be allowed to participate in any LHA activity until all outstanding financial obligations are met and the player is in Good Standing with LHA, as determined by the LHA Board Treasurer.
- 7. Suspension of a player for non-payment under the provision of Section 5 does not release the player or parent from the obligation to pay all registration fees or all additional team fee assessments.
