## Boys VP Update - Russ Cooley

### Age Policy:

- Want to move to USA Lacrosse 15-month calendar. Allows for summer birthdays to play with grade level, rather than strictly by age.
- Allows for 8<sup>th</sup> graders, who may have been ineligible to play with high school and boys youth, to play with grade level
- Clubs can use judgement for exceptional cases including grade accelerated youth, physically advanced or smaller players.

- Response from 6 clubs for 10 u goalie gear: Middleton, Janesville, Verona, Waunakee, Cap City, Oregon
- Survey of clubs did think they would have enough girls for 10, 12 and 14 u

## Walk On Items

### 1. Gender Policy

- Member clubs ask us to review policy. Had not been updated since 2010, was strictly based on boys/girls playing on team for age level.
- BLA would like to update the policy to align with USA Lacrosse policy to allow athletes to play on team matching their gender identity.
- Comments: Amber- agrees. Raised issue of a girl playing on boys' team due to convenience, not a gender identification issue. Can policy be inclusive to these instances? Felt player/family should make that choice.
- Verona- recommended organizational decision in nuanced circumstances.
- The group agreed that nuanced cases (such as girls playing on boys' teams when no girls' team exists) should be handled at the club level, with BLA providing inclusive policy language and deferring to club judgment for one-off situations.

- Board will vote in February meeting

2. Updated Supplemental Bylaws
  - will send out broadly to get feedback from Badgerland Clubs
  - Many bylaws were no longer relevant, specifically when governed high school, which we no longer do
  - Goal is to approve bylaws at February board meeting before next season
3. Review of Club Packet

  - Discussed potential for games on memorial weekend as well- (if a club participates in all 3 tournaments, leaves 4 weekends of games). Overall, sentiment was to leave Memorial Day weekend without games.
  - Coaches call in March will emphasize sportsmanship and role of Badgerland
