- 1) Call to Order/Determination of Quorum (Witte)

- 2) Open Forum Discussion (Witte)

- 4) Presentation and Approval of Last Month's Board Meeting Minutes (Edwards)

- 5) HDC Facilitation Update (Witte/Linke)

- 6) Hockey Operations Update (Schmidt)

 - a. \$3500 cost estimate for blade on zamboni. This is approved to be paid.
 - b. Expo rink issues. Lump in foundation/floor layer, in front of goal on one side, running ice thicker so that it isn't uncovered with zamboni at 1.25-1.5" thickness. Will need new foundation at some point. Had same issue last year.
 - c. Quotes are coming in for fire alarm system repair/update.
 - d. Discussions going on with AHA and Aberdeen Park & Rec to potentially increase utilization of the ice, possibly extending ice time later in spring and summer, potentially keeping boards up longer for roller rink/roller hockey.
