- Craig Tournament:

- o 2 of our youth teams were able to attend the Craig tournament.
- During the tournament it was observed that Craig had some fun fundraising ideas.
- One fundraising idea Craig had was a 50/50 drawing. It was set up so they had every player's name & number on a slip of paper on a board and you could "buy" your player for \$10. Then the pot would be split with whoever purchased the player that was drawn.
- Michelle will contact Craig and talk about their fundraising ideas.
- Zoom Meeting with GameBeast:
 - GameBeast is a company that has created an app for sports registration.
 - Parent's can do everything from the app (communicate, register, schedule, ect.)
 - GameBeast uploads and creates all registration info. They like to have all
 players, volunteers, and coaches register so it can finalize and track what needs
 to be filled out. (This would be nice with the updated USA hockey requirements.
 Our Registrar would have everything in one place and coaches can see
 everything so if something is missing they would know.)
 - Discount codes can be created.
 - Ach Fee 1.5%
 - Can we be flexible with payments?
 - It is auto default, however we do have options.
 - If a payment fails we will get 2 notifications.
 - The app schedule updates in real time. Players can put their availability in right from the app.
 - Admin and Coaches can see every players information.
 - Chat defaults to block adults from chatting with players.
 - Tuition and everything can be done from the app.
 - We might have to keep SportsEngine for the website and store.
 - The GameBeast Rep. said they can build a website for us for free and they would only charge \$150.00 a year for a housing fee.
 - The GameBeast app keeps track of jersey # and players can only pick from what numbers are open.
 - The app stores information (birth certificates, background checks, USA hockey #'s, ect.)
 - Push notifications can be sent for upcoming events.
 - They can make a custom form for players to upload birth certificates during registration as long as they continued to register for future seasons, the platform would continue to store them.
 - They are going to gather information on how to create an online store to add to the platform.
 - GameBeast has no annual fee. No hosting fee. No transaction fee. They also have 24 hour service.
 - They will need a couple of days to set up the platform.
 - They will train who is needed on how to use the platform.

- They said there is a contract, however they don't ever hold people to it. The contract is 1 year.
- o It is free to use and we pay roughly about \$800 or more a year for SportsEngine
- Chelsea finalized rosters this week to turn into the State. Rosters are now locked in and no changes can be made.

December 28, 2021
