

ASHLEY VALLEY AMATEUR HOCKEY ASSOCIATION
PARENT VOLUNTEER AGREEMENT - TRAVEL TEAM
Season: 2026-2027

As part of our commitment to maintaining a high-quality youth hockey program, we rely on the support and involvement of our families. Volunteer participation is essential to the success of our organization and helps keep costs manageable for all participants. This agreement outlines the expectations for volunteer service hours for the season and is a **required component of player registration**.

1. Volunteer Commitment

Each family agrees to complete volunteer hours during the 2026-2027 hockey season as follows:

- **8U/6U - 5 volunteer hours for the first registered player**
- **10U -14U - 10 volunteer hours for the first registered player**
- **5 additional volunteer hours for each additional registered player within the same family**

Examples:

1 8U Player = 5 volunteer hours	1 12U Player & 1 8U Player = 15 volunteer hours
2 8U Players = 10 volunteer hours	3 10U or high Players = 20 volunteer hours

Volunteer opportunities may include, but are not limited to:

- Game-day operations (scorekeeping, penalty box, clock)
- Locker room monitors
- Tournament support
- Fundraising events
- Team support roles (Coach, Team Manager)
- Facility or event setup/cleanup
- Board-approved special projects
- Raffle prize donations

2. Integration with Registration

- Execution of this Volunteer Agreement is **required for completion of player registration**.
- A player’s registration will not be considered complete, and the player may be deemed **ineligible to participate**, until this agreement is signed.
- By registering a player, the parent(s)/guardian(s) agree to be bound by the terms of this Volunteer Agreement as part of the overall registration terms and conditions.

3. Tracking of Hours

- Volunteer hours must be logged with the Team Manager.
- It is the responsibility of the parent/guardian to ensure hours are accurately recorded.
- The Team Manager/organization will provide periodic updates on hours completed.

4. Buyout / Unfulfilled Hours

If the required volunteer hours are not completed by the end of the season:

- The family will be invoiced at a rate of **\$25 per unfulfilled hour**.
- Payment of the invoice is due within **30 days** of issuance.
- Any unpaid balance must be settled **prior to the player's registration for the following season**.

Failure to satisfy outstanding balances may result in:

- Denial of future registration
- Referral to collections or additional administrative action, if necessary

5. No Opt-Out Provision

Volunteer participation is a core requirement of the program. Families may not opt out of volunteer hours in lieu of payment unless expressly approved in writing by the Board in advance.

6. Exemptions

The Board may approve exemptions or alternative arrangements in limited circumstances. Requests must be submitted in writing and approved in advance.

7. Acknowledgment of Commitment

By signing below, the parent(s)/guardian(s) acknowledge:

- This Volunteer Agreement is **part of and incorporated into the player registration agreement**.
- They understand the volunteer requirement and associated responsibilities.
- They agree to fulfill the required hours or pay the applicable fee.
- They understand that failure to comply may impact current and future participation in the program.
