February 15, 2023

- There was massive confusion when the team manager job description was released and put into place immediately. Crista released the following statement with board approval in hopes to clear up the confusion.
 - "To clarify the spouse manager and coach conflict, after feedback and lots of discussion throughout the season we have come to understand there is a conflict of interest there. It can cause conflict between the spouse and coach, parents may not be willing to discuss things with the team manager/coach because of their relationship, and it can also reflect negatively for their player, with others being convinced that the coach/team manager's player gets favor because of the positions their parents hold. We as a board want to do what is best for the league. We have amazing coaches and team managers and want to protect them and our players as best we can. We understand this will not eliminate every conflict within our association but we want tot do what we can, where we can, and hope to see the association grow and thrive. This policy will be enforced next season. No team managers are being removed. No coaches are being removed. In the past coaches have run for the board and sat on the board. As well as spouses. The board is an entity made up of 7 people with 7 votes before anything is passed. When in a board setting if it si viewed and determined that a board member has a conflict of interest then that board member is asked to be removed from the vote. Their vote is forfeited. We encourage everyone that wants to run for the board to run. I hope this can clarify some things. I apologize for the confusion and I appreciate your patience and understanding as we try and navigate how to grow and strengthen our league."
