Financial Review

General Overview & Budget

- Any big income or expenses?
 - Savings: ~\$21k
 - Checking: ~\$16k
 - Still need to deposit Midwest Beverage refund - \$506.82
 - Registration fees that have not cleared - \$1500
 - Outstanding exp – team registrations for tournaments
 - \$2,600 made from previous raffle items.
- Revisit money market account at the end of the 2025 season.

Venmo Account

- Brandon Schreiner converted account and it has been in use to receive the travel league holding fee.

Raffle Items

Previous Year's Items

- Jim Henaman has helped sell three of the items raising \$2,600 for MYB.
- Four more items are currently out at bars. Nine more items to go.
- Jim Henaman to continue selling legacy items and updating the board with progress.

2025 Season Items

- Will Charlie's consider going back to not having to purchase the items for the raffle?
 - Yes, we don't need to purchase the items up front.
 - Jerrod Gould to reach out to Charlie's and start getting a list of items.
- Do we need to do anything about the raffle license?
 - Jerrod Gould to reach out to Andy Adams on this process.
- Want to print 2,500 tickets right away.

Attire

- Brad Menning to acquire some quotes from other suppliers and make a recommendation on who to get our attire through.
 - 4 seasons – No quote received – last season's quote is same as Smiles + Heart
 - Next Level Creations – can reach out again through Facebook Messenger
 - Smiles + Heart – received quote - \$14/shirt for athletic material, \$12/shirt for cotton, additional \$12 for name and logo per shirt.
 - A&E – have not reached out yet – last year's cost was \$16/shirt for cotton and between \$17-\$18 for athletic material.

Sponsorships

- Brian Zell drafted up the sponsorship documents – support document and packages.
 - Brad Menning helped to add in the Travel League items.
 - This will be easier than doing many different packages just for travel league and introduce the idea for next year.
- Brian Zell requested updated logos from sponsors for the website in his email.
- Prices stayed the same as last year with some adjustments for the travel league banner item.
- Brandon Schreiner to give Brian Zell sponsor website access.
- Board to send Brian Zell sponsor ideas for new sponsors.

Photography

- Kyle Sabatke to gather board ideas for what we want in our photos and if you have a recommended photographer.
 - Next meeting we will discuss reaching out to our current photographer and any we want to consider.

City League Items

Babe Ruth

- The Mosinee Middle School appreciated the letters of support and discussed the proposal. There were some concerns with the current plan of the school adding these as a sanctioned sport.
 - Financial uncertainty: School is dependent on the bi-annual budget and other factors that make it impossible to predict financially absorbing the sports in three years.
 - Transportation: is currently at issue in the spring. While we think that we could provide it, that is before any weather turns our spring schedule to mush which then puts us in a spot where either we have to get MS teams to their events 3 hours early or cancel the game due to driver shortages to provide event transportation and fulfil our evening routes.
- The Mosinee Middle School is proposing adding MYB and MYGS as endorsed clubs; like how figure skating and trap shooting is handled.
 - MYGS and MYB would be able to use the Mosinee Indians school name and access our Middle School conference as an affiliated club to our Middle School.
 - Mosinee Athletic Department would work with our bus company to provide transportation to all possible events. This expense would be paid for by your respective groups. Any games that a bus could not cover, there is more flexibility for parents to transport for club events than school athletic events rather than cancelling.
 - Mosinee School District would not register any of the athletes or collect fees from them. This would be the responsibility of the clubs. This would allow you to charge a typical fee you normally would to cover your costs of this arrangement.
 - Mosinee School district would not hire or pay your coaches. Your club would choose the coaches and choose any/if any compensation for those coaches. We would need proof of background checks and all other requirements for those individuals to be around kids.
 - MYGS and MYB would provide the uniforms for the teams. Again, you could either build this into a registration cost or have an added uniform fee to assist with this.
 - As part of our conference, the games would be scheduled by our AD and our Conference. Umpire schedules would be coordinated between our AD and your organization. Umpire fees would be paid by your organization.
- Kyle Sabatke – ask Tom McCarty – clarify umpire scheduling. We understand we would pay for it. Also, clarify bussing expense.
- MYB to go down the proposed path by the Mosinee School District and investigate the fees so we can start registration.

Registration

 - Brad Menning – to post on Chamber of Commerce
 - Brandon Schreiner – Flyer design to be the same, just change the logo
- Emails with the digital flier will also need to be sent out to the schools and previous parent email list.
 - Brandon Schreiner can send out this email from the MYB Gmail.
- Registration to be open until March 7th.
- Registration Location
 - Where do we want to have the registration location for candy bar/raffle pickup and to help solve any registration needs?
 - At the MYB fields on April 8th and 10th – revisit each meeting.

Dick's Sporting Goods' Partnership

- Setup the Dick's Sporting Goods' partnership with Kyle Flanagan. Need to pick the shipping date and set the rest of the background items up.
- Chris Savickis to handle this with Kyle Flanagan.
 - Try weekend end of February or beginning of March

Lawn Mowing Equipment

- Chris Savickis pulled the mower batteries and keep on charger over the winter
- Chris Savickis to look at existing mowers and see if he can help with these as well

Field Maintenance

Fund Raising

 - \$1 bar cost has gone up \$1 PER CASE (not per bar). Worlds Finest Chocolate (WFC) is encouraging us to move to the \$2 bar.
 - Brian Zell to order 100 cases of the \$1 bar and have it shipped to Charlie's Hardware. Contact Jeff Kyhos at Charlie's to let him know they are coming.
 - Buyout amount

Travel League Items

Registration Review

- Registration fee tracking

 - MYB will issue \$50 discount codes to the parents that paid.
 - There is one parent that said they sent a check, but do we know if it was cashed? - We can reach out to the parent and if they say it was sent and it was cashed, we can issue the discount code then.
 - Linda Sabatke to investigate her tracking and Brandon Schreiner to ask if it was cleared.

 - Umpire situation looking good. Currently need one more for the first weekend and two more for the second weekend.
- Sun Balgord reached out about selling concession items at the travel tournaments again.
 - Yes, she can come for the 2025 tournament.

Travel League Player Status

- Should we be changing how players playing for multiple clubs vs strictly for MYB be handled?
- Tom McCarty, Dallas Weiler, Paul Haas, Brandon Schreiner, Ryan Talbert, Chris Savickis to determine how we want to structure the travel league player levels and see if any Bylaws need to be updated around playing for multiple teams and what costs should be charged to alternate level player.
- MYB will revisit this next meeting. This has been removed from the Bylaws and into another document.

DIBS Committee

- Committee proposed adding a 3rd person to each shift in the concession stand with a ½ hour overlap.
- Requirement Hours
 - Rookie – 3
 - Minor – 9
 - Junior – 9
 - Senior – 9
- City league must sell 5 tickets per player or owe for how many are not sold at the end of the year.
 - Increase registration by \$100 to include the 5 tickets cost.
 - Parents would sell and keep the cash or sign the name on their tickets and turn in.
- Buyout: \$200 for Rookie and \$500 for Junior-Senior
 - \$60 per hour paid for any unfilled hours and any signup, but cannot make it.
- Travel stays with 6 hours and 5 raffle tickets for Travel
 - Then they still need to sell the City tickets
- Board to review incentives to sell more raffle tickets than the 5 required (per league).
 - Competition for top sellers.
