Finance Committee Report

Proposed CCJHA player and team sponsorship fee increases

Unfortunately, rates and team sponsorship fees must increase. The Finance Committee met. Our proposed fees are:

All-girls teams in house division will pay the corresponding age division rate.

Finance committee needed to cover \$203K, we are projected for \$208K with rate change, doesn't include the increase in sponsorship (division sponsors), if so, 8U fee would drop a bit and they'd wear stickers on the helmets.

Sponsorship Fees

Rate will increase to \$1800 (\$1200 to CCJHA, \$600 to tournament fees) this is a 2-year commitment.

Travel

Rate will increase to \$3000 (\$2000 to CCJHA, \$1000 to team for tournaments)

CCJHA age group sponsorship opportunities (I. Repp)

Ian Repp talked to Brandon at Keweenaw Chevy. He is interested and is looking at his current budget for next year and will get back to us. Ian has a plan to start the conversation at \$10,000, for sponsoring 4-5 mite teams. Ian told him we could do helmet decals and brainstorm on any other ways we can promote Keweenaw Chevy. Ian is prepared to go to \$8K IF needed.

Ian will talk to Eric Waara or Jeff Jepsen to find out who we can contact at Dunkin Donuts.

Ian will also work up a letter and terms for a division sponsorship.

Our prices don't include age sponsorship, so any funds will go toward the younger kids to keep them coming into the program. If there is an opportunity for someone to sponsor all girls, we can do that as well. Other ideas were Michigan Tech Athletics (Junior Huskies).
