Travel Committee Report

Solicit for travel coach applications in February/March 2023 and earlier tryouts.

It was asked if this would negatively affect CCJHA kids who might want to play a spring season in WI or MN by conflicting if tryouts are earlier (in Spring). This was discussed; it should not affect players.

The teams cannot play games until September 1.

There was no perceived drawback to soliciting coaches to apply for the positions earlier than we have in the past.

Action item: post travel coach application prior to the end of the season. Once coaches are confirmed, the discussion on when tryouts will take place can resume.

Second AA or A team at 14U/12U level?

Question was raised if we will roster another AA team at the 14U level as we did this season or add a 12U team. We will need to look at numbers at these levels before that decision is made. It was also suggested that we talk to Spencer Jenkins, J. Peltier coach, about how this first season went with scheduling.

Replacement of goalie helmets (update)

We are still waiting on the younger kids' helmets.

Colleen Mayra sent multiple emails to Jason Reynolds and hasn't heard back from him. She talked to Michele Lacourt and they are trying to find out more information.

Division 2 JV Team jerseys update (Jim's Pizza jerseys order)

Jerseys were ordered, but there is no delivery date as of today.

Dee Stadium Mite netting replacement (Travis reaching out to J Jepsen)

The mite nets need to be replaced. We have a mite net at Houghton County that has a broken weld. The Booster Club is getting prices on nets and frames/nets from Erik at Center Ice. Once he gets her the numbers, Colleen can work with TJ and see about the Booster Club paying for replacements, depending on cost.

The girls are playing this weekend and need jerseys. We will borrow jerseys from our current CCJHA stock for those games.

According to the coaches, the numbers are starting to fall off for the girls. We would like to keep the momentum for this program. The coaches asked if the Board could apply for a grant from the Slim Maclean Memorial Fund to get either practice jerseys or hats for the girls. We will look into this.

Booster Club Report

Fundraiser update

Jim's Pizza wanted to do a gift card fundraiser. We are going to look into other options instead, perhaps involving them in the AA district tournament with pizza sales.

Zero Tolerance Policy poster update

Colleen is talking to rinks to put the posters in more obvious places.

Team pictures update

Colleen is working with Kitti and the photographer. We are looking at January 24 and 25 for pictures. Instead of having them on ice, we are talking about doing them on a green screen and adjusting the

scheduling of pictures to families instead of teams, so that families with multiple kids don't have to try to sit through multiple photo sessions. More information forthcoming.

Coach/Coaching Director/RIC/Referee and vice versa communication Update

12U AA coaches, Ian, and Jeff spoke to the parents in question and there have been no issues since. Jeff was supposed to email board. Both were apologetic and are aware that disciplinary action could be forthcoming.

Registrar/Safe Sport Report Program Director Report
