D10 Presidents Report (attended by Mike Possin)

- MN Hockey - New move up policy regarding waivers is being voted on soon. Trying to move back to a community based program and not allowing school based waive in's until after a certain time period. This would be for new members, not existing. Existing would be grandfathered in.
- Abuse of officials is still a concern. Game mis-conducts will be handed out more frequently.
- Fighting: You will be done with the season if you get a 3rd fighting misconduct in the season.
- Rescheduling: Need to follow the D10 Policy, including updating Tom Nergard.
- Disputes about penalties need to be brought up with the officials right away after the game.

Regular Report

- Outdoor rink is up and complete.
- The City of Elk River did approve our lease for the outdoor rink last night, 1/16/2024. \$500.00 per month. January – April. Rink has to be torn down and repairs to property made by April 30, 2024.
- The City was initially going to pull our water and electricity access, but it did get worked out.
- Water is through ERMU. They rented us a fitting/meter to fill the rink and then a different one for flooding/maintaining ice.
- Purchases have been made for the rink and items for tournaments that we approved last month.
- A supplemental insurance policy has been purchased for the rink, which is on top of what USA Hockey allows.
- We will follow all USA Hockey rules for the outdoor rink.
- The rink will not be open for public use at this time.
- Would like to host some internal “tournaments” utilizing it with the younger groups.
- Furniture and Things is donating a “warming house” for the outdoor rink. We will need to winterize/insulate it and add rubber flooring.
- This will be a good trial year. Hoping to build and expand on this as the years progress. Looking at other locations like Egan or St. Louis Park. They also have outdoor locations and Egan has moved to a covered sheet.
- Summer goalie program with Devenir – Maple Grove might be the only options. They are still working on a plan for possibly doing one in Elk River.

- Dryland area is now complete. Ben creates his schedule for dryland on a google doc that is shared with the City and Jess. Coaches can now utilize this space for non scheduled days, but need to reserve the space. Jess will get a google doc prepared for this. It does need to be a rostered coach running the space. Teams also need to be made aware that it's just a stick handling/shooting space. We do not have access to the turf.
- Playing time: There have been some concerns raised with how coaches/teams are handling playing time. Specifically, it surrounds kids that don't show up for practice, but are in attendance for games. Equal playing time? We may need to tweak our playing time policy around this so coaches can hold players somewhat accountable with attendance and attitude. We do have an equal playing time "rule", but it is different for each level. Equal isn't exactly equal, but as good as we can be. Example: Squirts – all players should have equal time per game – not necessarily per period, etc. – Playing Time Standards - We will table this topic for this meeting, but will revisit and work on policy this summer. If a board member has an idea on how this policy should be updated – present it on group-me for further discussion.
 - Potential Policy: Fair playing time will be at the discretion of the coach with the intention that it is as equal as possible. Any concerns with this can be brought to the attention of the board for review during the season.

Issue: Goalie Shortage

“For teams that have only 1 goalie, that goalie will play in all scrimmages, games and tournaments, unless any of the following apply:

-The regular goalie is sick

-The regular goalie is injured – The head coach receives board approval from the ERYHA board or level director for another player to play goalie.

When required by D10 policy, the 10 substitute goalie form may also need to be completed.

In recognition of the shortage of goalies in the game, ERYHA encourages any rostered player that wishes to try goalie, be able to attend and participate in practices as a goalie as long as the head coach approves it.”
