- 1. Call to Order 7:08 p.m.
- 2. Dave Armstrong moves to approve June minutes, Sabrina Frey seconds, minutes approved
- 3. President's Report: Jeff Barfield
 - a. Registration
 - i. All materials have been sent to NGIN, we are waiting for them to complete
 - 1. Asking that once it goes live board members register right away so that we can figure out if there are any bugs
 - ii. Tentative dates for Registration period August 12th 30th
 - b. Team Sizes for 2013-2014
 - i. Bantams 2 or 3 teams depending on numbers
 - 1. Concerned about making 3 teams that are too small we are a bit short for making 3 teams
 - Looks like it will be 31 who are not trying out for HS and 6 or 7 who will be.
 - b. Possibility of forming a coop with another club for a third team
 - 2. We will see where we are at the registration deadline
 - ii. PeeWees 3 or 4 teams
 - c. Release Requests
 - i. Polar Caps policy is not to release players, we are going to stick with policy and not release the skater.
 - d. 2 requests to transfer in
 - i. Mark Rufenacht has heard from a PeeWee from Oregon and one from McFarland who want to transfer in
 - 1. These 2 kids would displace 2 of our kids
 - 2. Sabrina Frey asks if we have enough coaches for 4 teams right now we are anticipating 50 PeeWees
 - 3. Currently there are no other PeeWees that are on transfer from another club, so we do not risk state competition eligibility by taking these transfers
 - 4. If we have to make 4 small teams, costs will go up for ice
 - e. Play Down Requests for rising Bantams that have fall birthdays
 - i. There is a dr's recommendation as well as approval from WAHA
 - ii. Request approved
 - f. Goalies have been receiving a discount for the last several years, Jeff recommends that we change the focus of these dollars to training
 - i. This was done to encourage people to be willing to let their child become a goalie
 - ii. There has not been significant growth in the number of kids playing goalie
 - iii. Perhaps if there was more goalie specific training this would drive interest
 - iv. Larry Clemens in Oregon is offering a Sunday night clinic and the cost for all club members to participate is \$650

- 1. Kristi Yaeger moves to raise the fees to standard fees and participate in the Sunday night clinic Laura Humphrey seconds approved
- g. Meeting with UW staff to determine if they could support our program
 - i. Perhaps they could help with a youth tournament
 - ii. They may participate in November 1st and 2nd's Youth hockey weekend
 - iii. They have to be careful not to interact with high school kids
 - The parameters are strict for whole club events, much more flexible if a specific coach asks for participation from UW hockey players just for his own team

- i. Marsha Shepard
 - Marsha has an ill family member and feels she will not be able to give her attention to the tournaments
 - We need to consider whether we can take up the slack of should we cancel the fall tournament
 - a. There is no one on the board prepared to take over this effort.
 - b. We will use the ice for home ice
