- 1. Call to Order 7:10 p.m.
- 2. Minutes from meeting 5/29/12 Jamie Vandermeer moves to approve, Tony Marcin seconds. Approved
- 3. New Business / President's Report:
  - a. Concession Proposal:
    - i. We will pay rent to MIA of \$5,000/year
    - ii. 4 staff members to get skater credits
      - 1. Nicole Harrison General Manager \$750
      - 2. Michelle Barfield Scheduler -\$750
      - 3. Pat Powers Asst- \$750
      - 4. Stefanie Statz \$750
    - iii. Approximate Parent Volunteer Hours(includes concessions and tournaments)
      - 1. 8-10 hours per family for competitive teams
      - 2. 4 hours per family in X-ice
      - 3. 0 For intitiation
      - 4. Work to Skate will be built into concession
      - 5. How to insure that families will work
        - a. Kyle explains that other clubs take the buyout money up front and you get it back as you work
        - b. Recommendation to get Credit Card #s
          - This is a security concern more than the board should take on
      - 6. Exemptions to be considered Decision will be made 6/26/12
        - a. Head Coach
        - b. Asst Coach
          - i. Tricky for RWB because of the numbers
          - ii. Concern about reducing the number of workers to dramatically
        - c. Board
          - i. Concern about asking the members to do this if we don't
          - ii. Lots of folks putting it a lot of hours it should count
        - d. Wondering if we can set up Dibs to require different hours for different people. Dave Armstrong will talk to NGIN.
      - 7. Buyout \$300-\$350 Amy Garvey reminds us that we do better to pay a worker and take the buyout, so we should not make it too painful
    - iv. Dicks gave us a cash donation and will be giving the club and members coupons to use.
    - v. Registration
      - 1. Dave Armstrong says that the preliminary registration is built
        - a. Includes
          - i. Concussion Form

- ii. Code of Conduct will not be included as the kids must physically sign the forms
- 2. Kristi indicates that there are several things to resolve before Registration can be built
  - a. Amount of Volunteer buyout
  - b. Volunteer hours required
  - c. Prepaid cards for concessions
  - d. Approve fees Bantams will keep same fees for Preseason ice
- Registration should include the \$75 fee several families owe that did not fulfill their volunteer obligations last year – if this is not paid families will not be eligible for preseason ice

  - a. 1 family is unexplained, 1 has family financial issues, the final family is probably moving from our area – they will need a financial release from us to play elsewhere
  - b. These families must be paid in full to participate this year

      - 4. RWB 51-60 estimated 36 confirmed, 2 nos, 28 no responses there is the possibility of additional skaters not in our system at this time
