Shakopee Boys Basketball Association – Board Meeting Notes from 7/15/18 at Muddy Cow

- Members present Don, Sachin, Mike, Jen, Chris, Wanda, Pete, Brooke, Jason
- Wednesday 8/08 Don attending MYAS meeting
- Discussed terms for each position to allow for alternating re-election
  - o Pete, Jason, Wanda, Brooke opted for 1-year terms
  - o Don, Mike, Chris, and Sachin 2-year terms
  - Jen 3-year term for treasurer
  - Suggestion was made for Don to help train in 3<sup>rd</sup> year when new in-house coordinator steps in. Wanda suggested previous experience needed to take over for her position
- Bylaws need to be rewritten. Per Bob Techam during transition of the association, a local lawyer has offered to do this free of charge. Mike will begin this process.
  - We create bullet points and he writes the sentences/legal language. Post on website when complete
- Board members to email Mike with any additions/changes to job descriptions throughout their term
- Discussed having a parent meeting before tryouts to educate parents and potentially try-on basketball apparel for ordering.
  - Thinking on Sunday 8/26
- DIBS was discussed. Potentially \$300. Hand in check to travel coach at first practice before uniform is delivered to the family. Winter travel only
- Next meeting dates set at Mon. 8/20, Mon. 9/10, and also Wed. 10/03
  - All at 6:30pm at SCC
- New fiscal year TBD by Jen may be April or May now to align with end of spring season but be before we start paying for next year's tourneys
- Committee updates:
  - Finance working on 501C forms. Wanda to get track example as they just filled this form out. SBBA is incorporated right now and tax exempt with the state of MN. Working on getting tax exempt with the federal govt. Boosters/HS Ball/SBBA have some account/funds that overlap so that needs to be straightened out and separated. Jen is working with a tax accountant to get us on the right path. Using Quickbooks so new charge of \$50/month on the books now. Roughly \$200K annually goes in and out of our account.
  - o Sponsorships Sachin said no help was needed
  - Equipment at log cabin for now, Sachin to consider finding a sponsor to trade storage space for ad space. Pete has a few helpers lined up to assist him in counting/moving any equipment soon. Will build a list/spreadsheet of inventory. Consider buying pinnies for tryouts and to use at practice. Talk to Gary at Innovative Graphics for pricing.
  - Operations Subcommittee clarified role as making recommendations related to basketball/tryouts to the board. The board can then vote on recommendations and discuss any concerns with operations committee
  - Director of Volunteers Wanda was notified of 4 different Sundays that are on the calendar for Shakopee to host. Only using 4 courts at SHS – not field house.

- Fall registration opens 8/05 and ends 9/07. \$70 registration cost
- Apparel shooting shirts to go long sleeve this year. Work to have samples at the parent meeting/open house on Sunday 8/26. Registration is online this year so we need to have a face-to-face opportunity to show people the new apparel and try on sizes
- New domain to be registered plus all board members get their own SBBA email address
- My Team Genius used for tryouts and scoring this year. Automated
- Non-parents don't need to be added to email blasts, just refer them to website for all the info they would need
- Jason started registering for tournaments, got some feedback from last year's coaches on sites to consider/not go back to
- Don is looking for officials for in-house league
- Talked about doing early bird pricing at \$110 (down from \$125) for winter travel and possibly paying for both fall and winter at the same time. Have to figure out if system can separate the two registrations if you only do one payment.
- Sachin doing program at Shakopee hosted tournament. Presented potential sponsor outreach letter to the board to review, already signing on some sponsors
- Shakopee tournament is 76% full out of 160 teams. 8 of the divisions are full

Shakopee Boys Basketball Association – Board Meeting Notes from 8/20/18 at Shakopee Ice Arena

- Board Members present: Sachin, Mike, Jen, Chris, Wanda, Pete, Brooke, Jason
- Kevin Wetherille, local attorney and basketball parent, presented on getting our bylaws rewritten. Takes 3-6 months to accomplish.
  - Bylaw review committee Brooke, Jason, Wanda, Mike, and DeeAnn Radzak will work with Kevin
  - Recommended some committees be set up on an ad-hoc basis when not needed long term
  - Advised to figure out how to separate Booster Club with maybe a committee that reports to the board, but keep their funds separate.
  - Advised to define roles of varsity coach or other coaches (i.e. voting vs. non-voting). Currently varsity coach has a position on the Operations Committee
  - o Recommended rotating board position re-elections every year to two years.

#### Volunteering

- Head coaches are awarded their DIBS hours for the entire season. Distribute an additional 6-8 hours (depending on what the minimum is for that year) to assistant coaches at will
- Collect \$300 check per family at tryouts
- Wanda consider using parents (instead of HS students) to run clock in winter season if DIBS positions are needed
- Fee discounts for winter travel
  - Head coaches fees are covered by SBBA
  - Board members fees not covered
  - Site coordinators 50% off all registration fees (for all seasons)
- Registration Fees Mike created spreadsheet to gauge costs and expenses for the year.
   Used as a discussion point by board to set travel fees.
  - \$285 + \$110 early bird fee or \$125 standard fee = \$395 or \$410

# Apparel

- Buy evaluation jerseys for every player the first year from Innovative Pete McGee. Maybe use every year and store or have families use the same one every year. Will evaluate at the end of the fiscal year.
- Wanda doing long-sleeve shooting shirts with Innovative. Mike to check on switching up the logo for this year

#### • Committee updates:

- Finance Jen spending lots of time on 501C forms. Has to wait for bylaws to be rewritten before completing. Boosters/SBBA have some account/funds that overlap so that needs to be straightened out and separated. Bob Techum should be delivering year-end financials soon so we can see how last year closed out. Collecting more money in fees for Shakopee Tournament (\$40K) then sending out for entry fees for our own teams (\$25K).
- Sponsorships Sachin looking for connections with local businesses, recommended asking at parent meeting on Sunday

- Equipment Pete buy new clip boards and possibly new ball bags where needed.
   Donate extra shooting shirts/hats/etc.. found in the log cabin to SBBA golf tournament. Pete noted grades 3/4<sup>th</sup> in MYAS will be switching to 27.5 sized balls
- Director of Volunteers Wanda looking to find a few folks to start shadowing for site coordinator positions for next year. Promote at Sunday meeting and on the website.
- Travel MYAS asking to rename teams to align everyone in the league. Now will be Shakopee, then gender, then grade, then level. (i.e. Shakopee B-4B). Jason still needs to sign up for a few tournaments. Update Tryout handbook to note that coaches will not evaluate their own child. MYAS updated 3/4<sup>th</sup> grade to 27.5 sized basketballs
- Tournament 269 games to be scheduled for Shakopee January tournament.
   168 teams registered. Tourney will schedule from 8a-10p on Saturday and 8a-9p on Sunday. Chris will follow-up with all Shakopee Tourney entrants to verify payments.

Shakopee Boys Basketball Association – Board Meeting Notes from 9/10/18 at Shakopee Ice Arena

- Board Members present: Don, Mike, Jen, Chris, Wanda, Pete, Brooke, Jason
  - o Bylaws committee meeting scheduled for 9/26/18 with Kevin
- Travel Fee discounts per year- <u>for use with one kid only</u> (everyone pays the initial registration fee for winter)
  - Head coaches 50% off travel fees for Fall & Spring, Free travel fees in winter season
  - Assistant coaches No discount for Fall & Spring, 25% off travel fees in winter season per assistant coach (up to 2 total discounts allowed in winter, max of 50% per team)
  - Board members 50% off all travel fees (for all seasons)
  - Site coordinators 50% off all travel fees (for all seasons)
- Parent Sarah Snell voiced her thoughts and concerns on the mixing of playing levels for the 7<sup>th</sup> grade fall season. Two equal A teams were created at that grade level only, meaning historically B players are playing up with historically A players. Her thoughts:
  - o How does the operations committee/board make these decisions?
    - Don West explained that the operations committee made this choice based on play and competition from last year, the need to challenge players that had played on the B level previously, as well as coach's recommendations
    - They felt there were many talented B players at this grade level that would be well-suited to play up in the fall
  - o Was each grade asked to do this mixing of levels as well?
    - Don/Mike said yes it was an option but it was decided that only 7<sup>th</sup> grade would try it to see how it works
  - O What is the metrics for measuring the success of this strategy?
    - Don/Mike are planning to use the success of the individual players during the fall season, as well as the team's win/loss record, to determine if this idea was successful
    - It was reiterated that fall play/success will not play into winter travel evaluations
    - It was also discussed to do a parent survey at the end of the season
- Parent Chad St. Martin brought up concerns regarding late practices on weeknights (until 10:00pm) as well as scheduling Wednesday practices that conflict with church/confirmation classes
  - Mike has discussion planned for Thursday, 9/13/18, with Jon Janke the facilities director. Hoping to get our teams in the field house to avoid scheduling conflicts with other sports as well as late practices. School district is asking for the association to pay for field house use.
- Fall tournaments schedule at SHA is 8a-5p. Wanda would like to arrive by 7:30am so facilities personnel from the school should be there to open up by 7:15am.
  - o Total usage fees are \$1,152 plus an additional undetermined supervisor fee
- 3/4<sup>th</sup> grade ball size change to 27.5" per MYAS rules
  - o Pete ordered 12 ball of this size
  - Start using this ball size in 1<sup>st</sup>-3<sup>rd</sup> grade in-house

- 40 families unknowingly didn't apply discount code for early bird registration
  - Jen and Mike will adjust the family's payment to refund the \$15
- Saber League (In-House)
  - Valley Sports getting business for the new reversible jerseys for in-house. Players keep jersey. Pete to work with Valley on design and getting them the logo. Goal is to keep the jerseys under \$25/piece
  - Don proposed working with the TWolves partnership for Saber League. Get logo on jersey, training sessions, discount tickets to TWolves game. Pay \$8/player for licensing fee to TWolves.
  - o Board voted unanimously (via email) to set in-house fees to \$160 this year
  - Move up registration dates to have time to order new jerseys
- Board voted no to donate camp fees, apparel, registration fee discount to SACS silent auction (1 abstention)
- Brooke and Jen to coordinate volunteers to manage check-in process at evaluations.
   Work with Chris and also site coordinators to create a schedule. Jen to manage ledger for DIBS deposit checks.
- Finance
  - Still waiting on Bob Techum's delivery of the year-end financials so we can see how last year closed out.
  - Jen to move any Booster money into the SBBA account but allow Boosters to run themselves and their budget separately. Booster also have a separate account they use themselves.
  - o Jen to bring cash to tournament Sunday and help count the \$ at the end
  - o Jen needs inventory lists from Wanda and Pete for insurance purposes
  - Need all board members to email Jen their home address
- Apparel
  - Pete ordered evaluation jerseys for every player the first year from Innovative –
     Players keep their jersey between tryout dates.
  - Wanda to manage ordering coaches apparel
- Sponsorships Sachin secured sponsorships with Hy-Vee and Qdoba
- Director of Volunteers Wanda to try Jimmy Johns for fall MYAS tournaments. Also interview Hy-Vee for winter tournament
- Travel Mike had to hire a coach for 5<sup>th</sup> grade fall season. Paid \$400
- Tournament 4 spots open for winter Shakopee tournament still
  - Looking for trainers for fall
    - St. Francis? Wanda ask Football Association?

    - Consider doing training instead, move to later September, do tryouts earlier?, less weekends?
    - Do a parent survey at the end of this fall season to get feedback
    - Start with less petty cash in Fall, like \$1,000
    - First three events profit is \$6,368
- Host 2-day Spring MYAS tournament on 4/27-4/28 (5/04-5/05 backup weekend)
  - Mike check facilities schedules
  - MYAS has asked about hosting Grade State for 2020
    - Boosters showed no interest in hosting
    - Association Board may consider
- Mike said most districts/associations he had talked to were staring with the new, smaller ball size for 3<sup>rd</sup>/4<sup>th</sup> grade
  - · We are sticking to larger ball until it is required at a tournament
  - Pete will put one smaller ball in each coach's bag for 3<sup>rd</sup>/4<sup>th</sup> teams
- Apparel Wanda will order based on final roster in mid-October
  - · In-house coaches warm-up shirt
  - Travel coaches— Dri-fit zip up
  - 1st round of apparel ordered by families has arrived distribute at tryouts. Profit was \$495
- Fall fee reimbursement
  - 50% refund for each child playing applies to head coach, board members, and site coordinators
  - Some people have spouses helping and/or the person has two roles. These folks will get additional 50% discounts applied. (i.e. Pete will get one child free and then 50% off his second child because Alisha is a site coordinator as well)
