Notice of Board of Directors Election

PLEASE BE ADVISED the Annual Election of the Timberwolves Hockey Club is open and accepting applications until **Monday, February 23rd, 2026 at 5:00PM CT.**

The Purpose of this notice will be to elect Board Members from among the current 2025-2026 members of the Timberwolves Hockey Club.

Who can run as a board member? Any person who has one or more children or legal dependents currently enrolled in the 2025-2026 Timberwolves Hockey Club program, and who is in Good Standing with AHA! and the Timberwolves Hockey Club, can serve as a Board Member. “Good Standing” is any Member who: (a) has completed the required AHA! forms and is a current paying AHA! member, (b) has paid and is current on all charges owed to the Timberwolves Hockey Club, and (c) does not have any matters pending before the Timberwolves Hockey Club board relating to rule violations.

Interested in serving on the board? Serving on the Board is your chance to make a difference in the Timberwolves Hockey Club. As a Board Member, you will be responsible for, among other things, establishing committees and appointing a chairman; creating and approving the budget for the Club; attending monthly board meetings and club events; becoming USA Hockey registered; completing the Safe Sport screening; and completing a background check. If elected, your official term begins on April 1, 2026.

Enclosed is a Candidate Application form to be filled out by interested individuals wishing to represent the Club by serving on the Board. Candidates seeking election must:

1. Complete the enclosed Candidate Application form
2. Obtain a minimum of 20 signatures from current 2025–2026 Timberwolves Hockey Club members
3. Complete all required materials and steps as instructed

Note: Only one signature per child/legal dependent registered to participate in hockey activities of the Timberwolves Hockey Club. If two members are associated with a single child participating in the Organization’s programs (e.g. two parents and one child), such signatures can be cast by either parent, not both.

All candidates intending to run for a Board position must be interviewed and vetted by the existing Board prior to the February 23rd deadline. All individuals intending to run for a Board position must notify the Club Secretary no later than **Monday, February 9th, 2026**, to allow sufficient time to schedule the required interview. No interviews will be conducted on the deadline date.
