



KLA Board Meeting Minutes Tuesday, July 8, 2025

Meeting was called to order at 6:17 pm at Keller Chop House in Keller. Board members present: Chris, Mike, Julie, Justin. Joining via Zoom/Teams was Colin and Matt. 2 members from the association also in attendance.

- I. June minutes were read; no edits or changes needed.

Motion was made to accept the June meeting minutes as read. Motion seconded; all approved. None opposed.

- II. End of Year Review – Pros and Cons
 - a. Age Directors
 - 1. Possibly add a tournament or two in fall
 - 2. Mix practices with both sixies and regular lax in Fall.
 - 3. Have one uniform you get in fall and then get shorts in spring. Keep HS uniform the same. Players that want a second uniform, a bigger size or different # must purchase on their own. Justin will open the store for families to purchase. All players pay the same registration fee. Only new players receive a uniform from KLA.
 - b. Financial – review proposed budget for 2025-2026. Need to nail down coaches budget asap to lock coaches in now. Would like to add purchases such as canopies.
 - c. Fundraising – lots of wins. Next year goal is to same or better by starting earlier. Also to have a better website. Matt will include Amy and reach back out to contact as Crossbar. How quickly can we integrate? Cost is \$1000/year. They make their money on the processing fees.
 - d. Social Media – lots of positive feedback with the field and player videos. Discussed videographer and possibly hiring for this job. Justin will talk to couple of coaches to measure interest. Brenda to continue Victory Club, Spirit Night, etc posts.

Motion was made to approve the coach's salary line item so KLA can issue contracts asap for Fall and Spring. Motion seconded; all approved. None opposed.

Motion was made to accept the results of the election by filling the Director of High School position with Kenneth Kirkland and Director of Youth with Matt Tobkin. There were no objections.

IV. New Business

- b. Fall Registration - Discussed cost and any changes. Majority agree to keep cost the same. Discussion on association wide registration being the same and pay for entire year considering entire year would be discounted versus just joining in Spring with the exception of brand-new players. Will ask Amy to send everyone the verbiage from last year to work on this year's email. Proposed fall start date 9/15.
