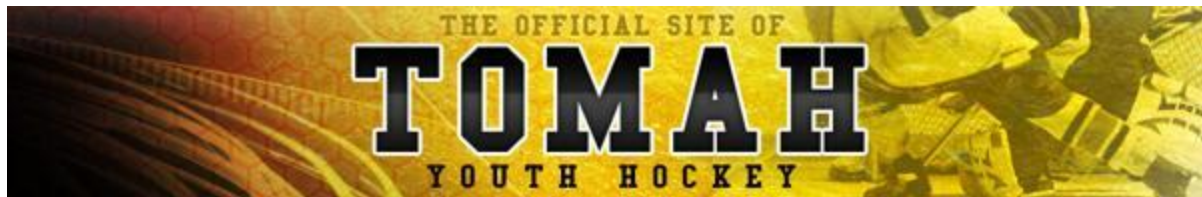
Opening Comments
