NEW BUSINESS

1. Blue Devils ice take over date / tryout dates / discussion and possible action: Motion made by Helgersen for take over date of 03/10. Tryouts to take place 02/28 and 03/05. Haun 2nd, all in favor – approved.
2. Wisconsin TNT 3 on 3 girls' tournament dates / discussion and possible action: Discussed difficulty in scheduling date prior to Kohlman Cup announcement and then comparing when other 3 on 3 tournaments are scheduled. Motion made for proposed date of 03/22 or 03/29 by Steele. Ravenscroft 2nd. All in favor – approved.
3. Conversion to Crossbar website platform / discussion and possible action: Discussion took place explaining current limitations with scheduling website and options presented by Crossbar. Motion made by Dettle to make conversion to Crossbar starting 05/01/25. Haun 2nd. All in favor – approved.
4. Rink offseason updates / repairs / discussion and possible action

- a. North and South end netting: Plan is to extend netting upwards this off season. Still need to look at how that will be done and access to lift.
- b. North and South end wall coverings: Coach Kirschbaum reached out to Baraboo Awning for quote of canvas-like material used at other facilities in the area. Also, looking at the cost of placing steel vs. canvas material. Coach Kirschbaum will follow up.
- c. Tables, chairs, stools replacement for warming area: Agreement will be off season project.
- d. Garage door opener / repair on north end of arena: Agreement will be off season project.
- e. Locker Room bench / locker sealant: Agreement will be off season project.

Old Business

- 1. Boiler repair update: Deans Refrigeration replaced two parts on boiler. No issues since repairs. Side note that LP heater has hole and Greeno will reach out to city regarding this.
- 2. Olympia Repair update: Serviceman was not able to come as previously schedule due to transportation issues. Greeno to reach out to Oliver to try and reschedule. Haun to look into current cost of new Zamboni machines.
