- c. *Ice Breakdown & Set-up for Next Season:* Shut down compressors May 15<sup>th</sup>. Rink tear down Friday night May 20<sup>th</sup> & Saturday May 21<sup>st</sup>. Set-up for next year will be Saturday Aug 13<sup>th</sup>. Should be skating by Sept 24<sup>th</sup>.
- d. *Future Fundraising:* Discussed several ideas including raffling a big ticket item, hosting a dinner similar to that of a hunter's night out, and expanding our tournaments. No action was taken at this time.
- e. *Team #s for next Season:* Cross Ice: 24, Squirt: 17 + 4 kids who played squirt Bs this season: 21, Pee Wee 14, Bantam: 6 – 11. Due to low Bantam #s last year, this coming year, and for the next 3 seasons we will look to co-op at that level with BRF. **MM, 2<sup>nd</sup>**.
