

BSA ANTI-DOPING POLICY

1 - COMMITMENT TO ANTI-DOPING INITIATIVES

Brazilian Soccer Academy is committed to support the anti-doping initiatives of the Canadian Centre for Ethical Sport, the Canadian Anti-Doping Program, the Canada Soccer Association, the Ontario Soccer and Fifa.

It's mandatory that all coaches and staff:

- Are aware of BSA Anti-Doping Police and where to find it (www.braziiansocceracademy.ca)
- Spread the word to the entire organization and external stakeholders and partners regarding doping and ethical sport. To be shared through team conversations, memos and seasonal informational documents
- Monitor suspicious behavior
- Inform management about any incident or suspicious behavior

2 - EDUCATION

It's mandatory that Brazilian Soccer Academy includes "Anti-Doping" in its coaching and volunteer training. The following links offer valuable resources that should be shared are discussed among coaches, players and parents.

THE CANADIAN CENTRE FOR ETHICAL SPORT - Canadians want sport to be ethical and fair for all athletes. The CCES is the custodian of Canada's antidoping initiative and is working to create an environment that matches the expectations of Canadians. To contribute to values-based sport for Canadians, and to help level the global playing field, the CCES manages the Canadian Anti-Doping Program (CADP), which is the set of rules that govern doping control in Canada. Compliant with the World Anti-Doping Code and all international standards, the CADP describes how the program is carried out and details the process of results management. It also sets the education standard for values-based sport in Canada.

THE CANADIAN ANTI-DOPING PROGRAM - The Canadian Centre for Ethics in Sport (CCES) is the custodian of the Canadian Anti-Doping Program (CADP), the set of rules that govern anti-doping in Canada. The CADP consists of several components such as in- and out-of- competition testing, education, medical exemptions, and the consequences of doping violations. The CADP is compliant with the World Anti-Doping Code and all international standards.
