GJNC QUALIFIED TEAMS WILL HAVE 24 HOURS OF POST-SEASON PRACTICE TIME. ALL GJNC & AAU NON-QUALIFIED TEAMS WILL HAVE 20 HOURS, STARTING IN MAY.
