 - Kachinas DC Decision – **See DC Report – The last DC meeting was a review of one of the Arizona Kachina's players. There was an exception granted for this Tier II, but was not done properly. The discussion with the Kachinas was to either suspend the coach, disqualify the team in the USA Hockey National Tournament process, or a monetary fine of no more than \$5000. The DC recommends a fine of \$500. Motion: Urban, 2nd Rice. To approve a fine of \$500 for the Arizona Kachinas for the improper execution of player exception. Motion passes.**
