 - Officiating Report (USA Hockey) – **No Report** – Going through the seminar certification process right now. Have 310 officials signed up to date. More females have signed up at this point than all season last year. All officials must be signed up by October 31st and their certifications must be done by December 31st. We have run 3 in person seminars so far. USA Hockey is changing the level system for officials. Levels will be more geared for your experience vs stepping through the levels. Will require AAHA Policy Updates.

 - Tier I Selection Committee Candidates Presentation – All candidates were listed and sent to the board for review.
 - AAHA / Matt Shott AZ Hockey Legacy Foundation Hockey Promotional – Commercial Vegas called today and have plans to do youth clinics here in Arizona. It will air around 367 times. Matt Shott

Foundation has offered to split with AAHA (roughly \$18,000 each group). It will drive visitors to each ice facility website for a look at all their specific programming. Will also be broadcasted on the local Sonoran Living tv program.

- **Minimum Age Requirements for On-Ice Officials – There has been no prior implementation for minimum age requirements for on-ice officials. Proposal for on-ice official age minimum would be 14 years old. Turnover rate was 61% of officials 13, 12, or 11 years old. On average these officials worked 18 games total per month. This age also has not acquired the experience with handling coaches and parents. Top two reasons for quitting is abuse and not working enough. Will continue the discussion and present a policy change by the December deadline.**
