

eCOLORADO AMATEUR HOCKEY ASSOCIATION BOARD OF DIRECTORS NOMINATION FORM

The Colorado Amateur Hockey Association (CAHA), a non-profit 501(c)(3) organization, is run by a volunteer Board of Directors. The CAHA Board of Directors is, among other things, responsible for the oversight of amateur hockey in Colorado under an Affiliate Agreement with USA Hockey and oversight of the policies and procedures of CAHA. ***Our directors are not paid and receive no other forms of compensation but rather volunteer their time and talent to promote the sport of youth hockey for the benefit of the players, their families and our local community.*** Board members meet throughout the year. During the weeks leading up to and during the hockey season, a larger commitment may be needed to handle issues during the season. In addition, Board Members assist with Try Hockey for Free, CAHA events and District/State Tournaments. All events are not mandatory, however, participation beyond attendance at board meetings is requested.

Persons seeking election to the Board of Directors should show a continued, vital and active interest in the affairs of amateur hockey within the Association’s jurisdiction and have demonstrated knowledge and skills in addition to meeting the requirements of the CAHA Bylaws. All interested candidates must be current members of USA Hockey, be in good standing with USA Hockey and CAHA, reside in the State of Colorado, and meet the eligibility requirements of the CAHA Bylaws and Policies and Procedures, including but not limited to Article 6 of the Bylaws and Section 25.3 of the P&Ps.

The deadline for application is May 1, 2026 at 10:00 p.m. MT and voting will take place at the CAHA Annual Meeting on May 27, 2026.

This form must be submitted by a CAHA Member Association.

Important: Nominees must indicate the specific Board position being sought. (Per CAHA P&P Section 25.3.7, nominees may not seek multiple positions).

Write-in candidates and floor nominations will not be permitted (P&P Section 25.3.15).
