**Review Meeting Minutes:** October meeting minutes reviewed: motion was made to approve and seconded - approved

**Secretary's Report:** No Updates

**Treasurer's report:** Review of October Financial reports - motion was made to approve and seconded - approved. Jeff Dolan Memorial fund will be moved to the Investment account. Discussed moving 100k from the gambling account to the general fund. Motion was made to approve and seconded - approved.

**Gambling Report:** The October gambling report and related expenses were reviewed. A motion to approve was made and seconded - approved. Etabs performed well in October. Initial starting cash increased to account for the use of a single cash bag for each game type. This change has been well received by the participating bars. Frickson Family Farms is now providing the meat for the Meat Raffles. Additional Meat Raffles will be added on Thursdays in January and February. LYHA volunteers will staff events on 1/8/2026, 1/22/2026, 2/19/2026, and 02/26/2026. Other organizations will be contacted to determine interest in covering the other dates. Bingo events are still being decided. Discussions will take place with the TOT and Sports Hub on each hosting one Bingo night per month.

### Discussion Topics

1. 2025-2026 LYHA Season Start: The 2025-2026 season is off to a strong start. Overall, Crossbar had been well received by LYHA families. Minor repairs were made to the compressors. The City of La Crescent will provide assistance in setting up the outdoor rink.
2. Team Volunteer Weeks - Eric W has finalized our team volunteer week schedule. Each team, Squirt through Bantam will be responsible for two weeks throughout the season, with mites having 4 weeks total. This information will be provided to teams.
3. Varsity Home Games/Practice Changes - Matt M will work on updating practice schedules for weeks with scheduled varsity games.
4. LYHA Toys for Tots Open Skate and Holiday Food Drive - There will be a Bantam team hosted 'Toys for Tots' event the Friday after Thanksgiving (November 27, 2025) from 3-5pm. Families bringing in a new, unwrapped toy, gift card, or cash donation will receive admission and skates to this open skate event. A hot cocoa bar will also be available. LYHA will also participate in the Branches of Hope Food Drive Contest to support the La Crescent Food Shelf. LYHA skaters will decorate ornaments to help make our tree festive. Photos of participating groups' trees will be posted on social media and members of the community will bring food donations to the trees they think are most festive. Donations will be accepted December 1-31, 2025 and will be weighed at the end to determine which business/group is the winner.

Pictures - Pictures for the 2025-2026 season will be rescheduled to the following dates/times:

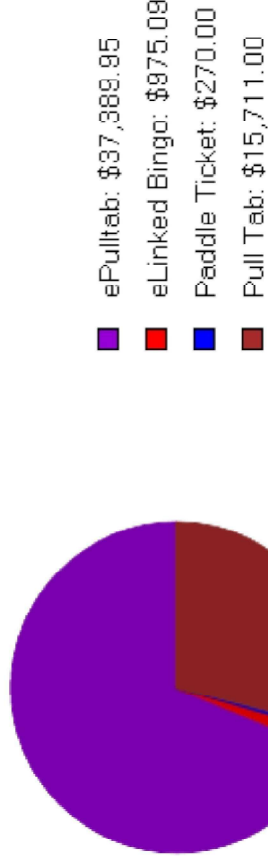

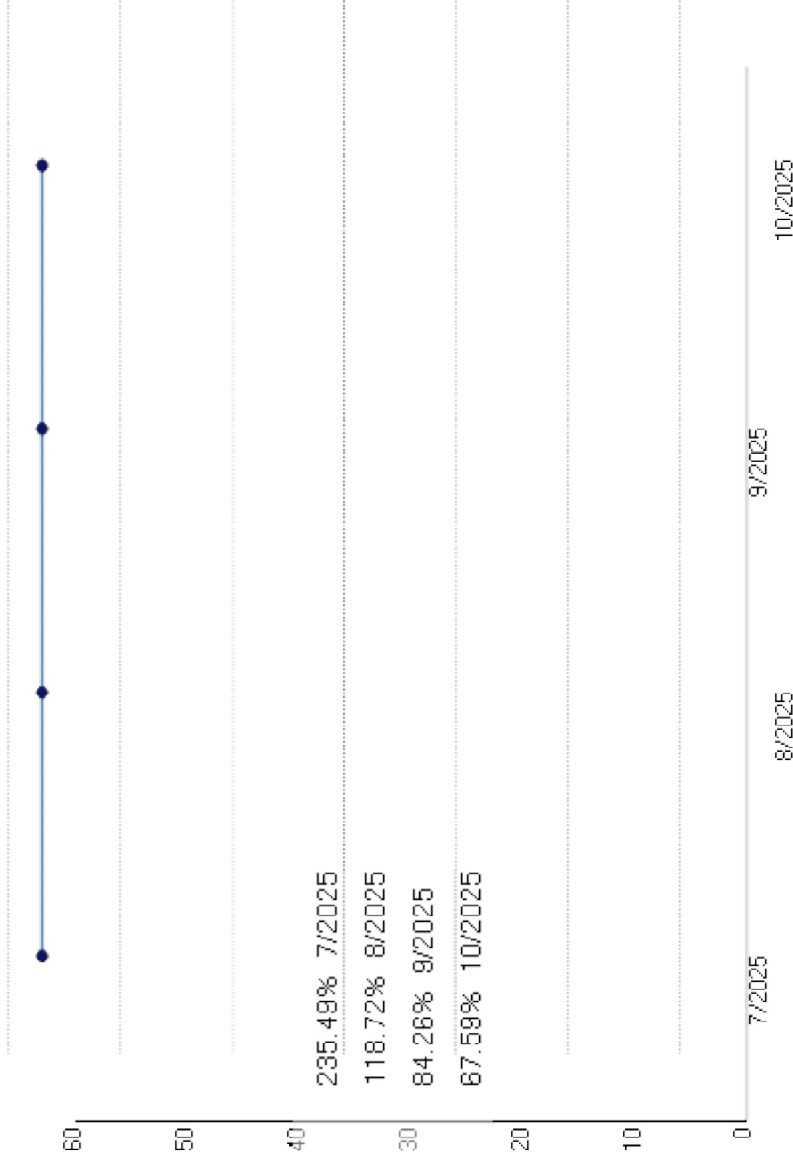

Lawful Purpose Star Rating



### 12-MONTH RATING PERIOD

For each 12-month period beginning July 1, a licensed organization will be evaluated by the Gambling Control Board to determine a rating based on the percentage of annual gross profits spent on lawful purpose expenditures. It is not a rating of its overall lawful gambling operation.

% Spent on Lawful Purpose*	Rating
more than 50% .....	5 star
more than 40% .....	4 star
more than 30% .....	3 star
more than 20% .....	2 star
more than 10% .....	1 star

### PROBATION.

An organization that fails to expend a minimum of 30% of gross profits on lawful purposes each year (July to June) is automatically on probation effective July 1 for one year. The organization must increase their rating to a minimum of 30% or be subject to sanctions by the Board.

### EXCEPTION

An organization that conducts lawful gambling in a location where the primary business is bingo (bingo hall) must expend a minimum of 20% of gross profits on lawful purposes each year (July to June).

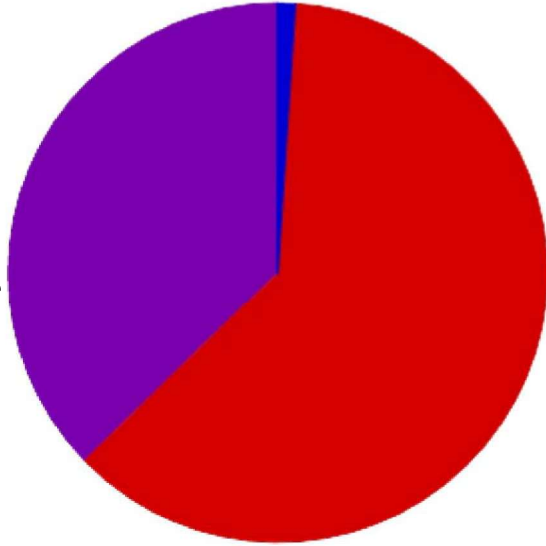

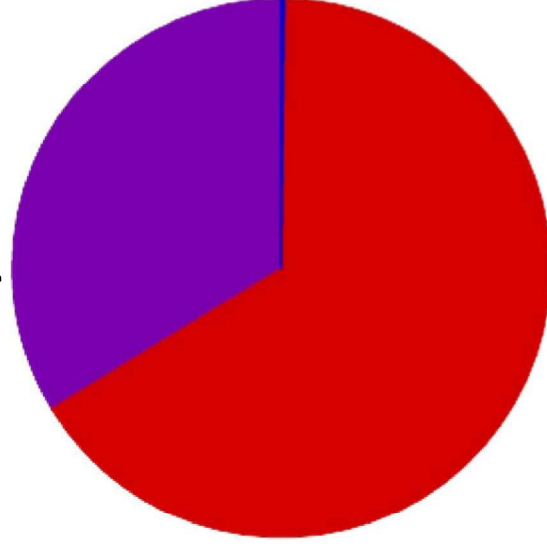
