2026–2027 Season Club Commitment Contract

Rush Volleyball Club LLC

We, the undersigned Player and Parent/Guardian, hereby confirm our intent to participate with Rush Volleyball Club LLC for the 2026–2027 club volleyball season. By signing below, we acknowledge, accept, and agree to the following terms and conditions of participation:

1. Commitment & Initial Deposit

Upon acceptance of a team placement offer, the Player and Parent/Guardian agree to submit a non-refundable initial deposit of \$1,000 (national) or **\$750 (regional)** to secure the player's roster spot for the 2026–2027 season. This deposit will be applied toward the total season fees and is due immediately upon accepting a roster offer.

2. Team Dues & Payment Obligations

- The total amount of team dues will be determined by the team the player is placed on.
- A payment schedule will be provided upon acceptance, with the remaining balance divided into manageable monthly installments.
- All payments must be made on or before the 5th of each month using the Rush Volleyball Club's designated online payment platform at www.rushvolleyball.com.
- A \$35 late fee will be assessed for any payment received after the due date.

3. Refund Policy

We understand and agree that all payments are non-refundable under any circumstances, including but not limited to injury, illness (including mental health), family relocation, scheduling conflicts, or removal from the club due to violations of team, club, JVA, USAV, or AAU policies.

4. Playing Time & Team Role

We acknowledge that payment of club fees does not guarantee any specific amount of playing time, role, position, or leadership opportunity. These decisions are at the sole discretion of the coaching staff.

5. Roster Adjustments & Team Movement

Rush Volleyball Club reserves the right to move players between teams for training or competition purposes. Regardless of team movement, we agree to honor the full financial commitment made at the time of signing. Any requested team change by the player/parent that results in additional cost will be subject to approval and an updated fee agreement.

6. Payment Methods & Authorization

We agree to process all payments through the club's automated billing system. We understand we are responsible for any NSF, declined transactions, or returned payments, and authorize Rush Volleyball Club to invoice accordingly.

7. Fee Inclusions & Exclusions

Included in the team fees:

- Uniforms
- Coaching
- Tournament Entry Fees
- Practice Court Rental
- Equipment
- Administrative Costs
- Coaches' Travel, Per Diem, and Lodging

Not included in the team fees:

- Player & Parent travel expenses (lodging, transportation, meals, etc.)
- USAV and/or AAU Memberships
- Travel to/from practices and tournaments

8. Season Duration

This agreement is valid for the entire 2026–2027 club season and extends through the conclusion of AAU or USAV Nationals in July 2027. Rush Volleyball Club guarantees a roster spot to the player for the full season upon acceptance.

9. Exclusivity Agreement

The Player and Parent/Guardian agree that participation with Rush Volleyball Club is exclusive for the duration of the 2026–2027 season. Participation in tryouts, training sessions, or competitions with other clubs is strictly prohibited without written consent from Rush Volleyball Club management.

Violations of this exclusivity agreement may result in:

- Immediate dismissal from the club
- Forfeiture of all paid fees
- Pursuit of outstanding balances or damages, as deemed appropriate by club management

10. Waiver of Disputes

We understand that club volleyball is a service-based offering. Therefore, we waive any right to dispute payments made to Rush Volleyball Club through check, credit, or debit card once submitted.

11. Acknowledgment

By signing this contract, we affirm that we have read, understood, and agreed to the terms outlined above. We commit to upholding our obligations with professionalism, respect, and integrity for the entirety of the 2026-2027 club season.
