2) Reading of the Minutes of proceeding meeting

- a) Motion to waive the reading of the minutes from the previous meeting Dolan Simmons
- b) Motion unanimously approved by the board members present.

3) Treasures Report

a) Laura Mooney (T) provided an overview of the league's financials. The general account sits at about \$57K noting new revenue from Spring Registrations, about \$8K; and \$2,400 in Sponsor donations. We expect more registrations and more sponsor donations to come in over the next month. No significant expenses expected the over the next month.

4) Reports of the Directors and Officers

- a) Equipment Coordinator:
 - i) Paul briefed the board on equipment. We sent 18 helmets to be re-certified, about 8 helmets were too old to be certified and we will be discarding.

b) Uniform Coordinator:

i) Jackie briefed the board on uniforms and apparel. Our Holiday Store closed and the league purchased 10 SBYL T-shirts to disperse this season to either coaches or players. Jackie will be reaching out to savage to get a quote on uniforms for the coming spring. Jackie will also get a quote for practice Jerseys for our U12-14 Boys and Girls.

c) Schedule Coordinator:

i) Brittany briefed the board on coaches for the coming spring. Brittany reached out to returning coaches to identify coaching vacancies. As of now we still have head

coaching vacancies for U12 and U14 Girls team, although there are parents who volunteered to assist or help out on those teams this Spring. We discussed advertising on our social media the two head coach vacancies. Dolan also said he would reach out to the SHS and NSHS girls lacrosse coaches to identify any recent grads who are in the area who may be interested in coaching those teams.

d) Registrations:

i) We are current sitting at 26 boys, 27 Girls, and 3 U7 Instructional players registered for a total of 56 which is about 25% of last year's registrations.

5) Old Business:

- a) 2026 Budget:
 - i) We discussed the 2026 budget noting no major changes to overall dollars but Paul did go in and identify Capital expenses to separate from the annual budget. He then prioritized those items so that we may decide to purchase as we hit certain funding numbers leading up to the season.
 - ii) One budget item we discussed was the practice pinnies for U12-14 Players. It was discussed that we could find a sponsor to pay for the pinnies in exchange for the business logo to be on the pinnies. Michael Vacca had volunteered to have his family business, Gary Vacca Building Contractors, a longtime supporter of SBYL, be the pinnie sponsors. Both Jackie and Paul said they would get a quote for the pinnies to get a final cost.

b) Try-it Day Lax Clinic

- i) Dolan is tentatively planning a try-it clinic for mid-January on a Sunday (date yet to be determined). Possible also holding a uniform try-on day if the try-on kits are available from our supplier.
- c) Uniform Try-on Day(s)
 - i) Jackie is going to contact Savage Teamwear to see when the try-on uniform kits are available and would like to schedule try-on Day(s) mid-week at the Mystic Firehouse a few weeks before registration close, sometime around the end of January/beginning of February. Registration closes February 21st.

6) New Business:

- a) Sponsorships
 - i) We have 2 Sponsors signed on with funds received (\$2,400). We have an additional 3 sponsors pledged just waiting for funds. Dolan has reached out to just over 50 local businesses and is continuing to contact additional potential sponsors. Sponsor goal is to match last year's donations of \$7k.
