Both the Vice President and Secretary seats are up for election in April 2025. Chuck turned the meeting over to Dawn Bryson. He thanked all the volunteers who continue to help advance the sport year after year.

Sent checks of \$7,679 to Vaugn for quick change goalie equipment utilizing some of the New England grant money for this. ODL information: please adhere to the 30-day notification procedure.

**Tournament Committee:** Matt Dutton- Congratulations to Chuck. If a team will be undeclared, please let Matt and Admin know as soon as possible if they are not participating in the end of season tournament. November is the deadline. We are using the list on the CHC website to put all the tournaments together in January. The CHC website needs to be accurate, please check that your teams are listed correctly on the drop-down list as declared or undeclared. Your team will be charged a tournament fee based on how they are listed on the website.

**Referee in Chief:** Kevin Redding – Congratulations to Chuck and Dawn. Recently there have been incident reports for penalties for aggressive plays not related to hockey play. These will be penalized appropriately and have no place in hockey. Please have general feedback run through reps and presidents and they can relay back to Kevin.

These are the rules regarding meeting attendance & good standing:

#### Article III Meetings

- 1. Each member program shall be represented at CHC Board Meetings by its designated representative, or in his absence, by an officer of the program, or by such representative designated in writing for that meeting. Duly represented member programs in Good Standing shall have the privilege to propose amendments to the Constitution, By-Laws, Polices and Rules, and vote on matters raised to the Board of Directors.
- 2. Regular Meetings will be held on the 4th Tuesday of each month, at 7:30 PM at the West Haven Italian American Club, Chase Lane, West Haven, Connecticut, unless otherwise decided by the Board of Directors.
- 3. The Annual Meeting shall be held in April, place and date to be determined by the Board of Directors.
- 4. Each member program shall be represented, as stipulated in paragraph (1) above, in at least 75% of all regularly scheduled monthly meetings. Should a member program fail to attend the minimum number of meetings, then a \$50 fine shall be added to that program's annual membership registration costs and such program shall not be considered to be in Good Standing. A member program may regain its status of Good Standing if subsequent to its loss of Good Standing, it has attended three (3) consecutive regularly scheduled monthly meetings or such sanction is lifted by petition to and majority vote of the Board of Directors, subject to the condition that if said member program has lost it status of Good Standing twice during the then-current season, the sanction can only be lifted by petition to and majority vote of the Board of Directors.
