- Bloomington Jefferson
 - Eastview
 - Rosemount
 - They train all aspects of the game and provide an environment where the athlete is allowed to grow into the player they want to be
 - They focus on improving
 - Footwork
 - Confidence
 - Mechanics
 - They offer the ability for us to come to their facility, or they can come to ours
 - Their facility can hold 15-20 players at a time
 - They work with individual teams, or multiple teams at a time
 - They offer pre-season training and in-season training
 - They have found with large groups it has been successful if they designate by grade
 - Sessions can go for 1 hour or 1.5 hours
 - They work on
 - Individual drills
 - Game situational drills
 - Scrimmaging or going against one another
 - They are willing to negotiate on cost the first year to work with budgets and then renegotiate and set pricing for the next year after that
 - They can help with training coaches if needed
 - Cornell will send Amy their standard pricing
- In-House /Rec
 - Go live for registration will be mid-August
 - Tani needs answers to the following questions prior to go live
 - How much per level will be charging
 - Still needs to be decided
 - Are will allowing 50% payment collected upfront and the other portion collected at the end of registration
