- **Financial Review**

Allen Larson took the board through the latest financial statement covering 8/15/23-9/18/23

Deposits for this timeframe were: \$1,600 donation from MBL, \$427 Shakopee Bowl Pull Tabs, \$114.93 rebate from tables and grill purchases for the Shakopee Tournament, \$900 Refund from the Burnsville Tournament, Kona Ice and Bravis \$81.90 and \$250. Total deposits \$3,374.29

Withdrawals for this timeframe were: transfer \$1,000 from LaCourse family over to the Stemmer Fund, \$2,240 on background checks with Trusted Coaches, \$75 on Credit Card point refund, \$400 auto payment not canceled credit card payment, \$125.58 florist for Matt Maslowski funeral (former board member), \$76.50 in Biffs in August at fields, \$256.42 to SHS for field rentals, \$18.18 shakopee public utilities for the electricity for the Jackson Township scoreboard, \$105 and \$105 for 2 umpire payments. Omaha money paid out to the families \$1,727.80. \$66.00 in office supplies for stamps, \$450 Survey Monkey Annual Fee. \$550.44 Crown Awards for 9/10U in house tournament. \$1,334 for Umpire Checks cashed (written out in June), additional \$534 fir umpire checks cashed (written out in Jul), \$60 for in-house ump and Sports Engine \$900 annual fee. Total Withdrawals for this statement were \$9,813.92
