- *Jerseys for next year - [Summary Comparison](#)*
 - Ben and Tessa from Little Big Promotions. Production time is 4-5 weeks and we would get it in hand in 6-7 weeks. Jerseys could be ordered at any time throughout the season

and we would not have to wait for a bulk order to process. They can do lots of other things besides just uniforms. Average jerseys would run \$60-\$70 each and \$30 for socks. They can match our current jerseys so families would not have to purchase jerseys for their existing player if they wanted. We should also look into separate socks for the white jerseys.

- Grant Gorman that runs the rink pro shop. Can match the jerseys close enough that people would not need to buy new ones that didn't need to. Endeavour hockey would be the supplier. They are based out of China. A link could be provided during registration and taken to the manufactures site for ordering. \$59 per jersey and \$22 for socks. Sizing could be done in the pro shop. Turnaround time is 2-3 weeks plus 3 days shipping.
