Hereby accept a position on the following team: Mid Fairfield CT Stars	

For the 2025-2026 Connecticut Hockey Conference season.

We, the undersigned player and parents/legal guardians of said player, by executing this Letter of Commitment, agree to the following terms and conditions of this commitment:

- 1. We agree to remain with, and actively participate in, the MFCT Stars/MFYHA program for the duration of the 2025-26 season.
- 2. We agree to pay the full season financial obligation as set forth by MFCT Stars/MFYHA, a Connecticut Hockey Conference member program. Tuition for the 2025-26 season is \$. .
- 3. We agree not to participate in any other youth hockey program, whether or not a CHC member program, for the 2025-26 season.
- 4. We understand and accept that if the above named player commits to the MFCT Stars/MFYHA program and subsequently refuses to participate with the MFCT Stars/MFYHA program that he/she is ineligible to participate with any other Connecticut Hockey Conference member program and must sit out the remainder of the 2025-26 season.
- 5. We understand and accept that a player who sits out due to refusal to participate remains obligated to satisfy any outstanding financial obligations due to the MFCT Stars/MFYHA program for the 2025-26 season.
- 6. We understand and accept that a player who sits out all or a portion of a season is not entitled to any partial or full refund of program fees or expenses.
- 7. We understand and accept that player must obtain a proper Connecticut Hockey Conference release from Mid Fairfield prior to registering with any new program in any ensuing season.
- 8. We, the undersigned player and parents/legal guardians further understand and accept the terms and conditions set forth by MFCT Stars/MFYHA and that this Letter of Commitment may only be terminated by mutual consent between the above named program and player. Upon such mutual consent, and payment of any outstanding obligations, MFCT Stars/MFYHA will issue a proper Connecticut Hockey Conference Release and the player may transfer to another program. Such mutually agreed on transfers must occur prior to November 1, 2025.
- 9. We, the undersigned player and parents/legal guardians, further understand that breach of any of the foregoing terms and conditions of this Letter of Commitment may result in the player's suspension or expulsion from the team as the Board of Directors of MFCT Stars/MFYHA deems appropriate.
